**MINUTES**

and 23 March 2010, from 9:00 to 12:30  
BRUSSELS

*The meeting opened at 15:07 on Monday 22 March 2010, with Erminia Mazzoni (Chair) presiding.*

**1. Adoption of agenda**

The agenda was adopted without modifications.

**2. Chair's announcements**

The Chair welcomed Ms Alicia Paz Antolín, representative of the Spanish government.

She also welcomed Mr Johannes Günther, Ms Anja Jonas, Mr Nico Tippeltand and Ms Ulrike Harzer from the German Bundestag Committee on Petitions.

The Chairwoman announced that the annex to the Chair's notes had been distributed a week ago containing recommendations on petitions to be reopened, closed or withdrawn. As no comments had been received, they were considered to be approved.

### **4. Statement by the Spanish authorities concerning the Ley de Costas petitions**

Conclusion: Pending the intervention of the petitioners foreseen for the following day, the committee concluded that there is a problem with legal certainty and just compensation, that the declaration by the representatives of the Spanish government and the Commission were not satisfactory and that the Parliament will pursue this matter.

Decision: Petition to be kept open. The Committee will monitor the effects of the new Directive providing a framework for credit rating agencies (entry into force December 2010, review 2011/12), based on updates from the Commission.

**7. Petition N° 1120/2009 by Marco Griffini (Italian), on behalf of Amici dei Bambini, on Romania's compliance with international conventions on children's rights**

It was agreed to postpone a decision on the petition until the following day.

*The meeting adjourned at 18:30; it resumed on Tuesday 23 March, 2010, at 10:20 with Erminia Mazzoni (Chair) presiding.*

**8. Chairwoman's announcement regarding the coordinators' meeting**

The Chairwoman announced the following:

1. Members decided to endorse the recommendations on petitions 1130-09 & 1243-09, 1245-09 & 1523-09, 672-09 & 865-09 and 1756-09 as suggested by the secretariat and detailed in the note distributed.
2. Members took note of the Draft Agendas for the meetings of 26/27 April and 4 May. The rules for attendance by petitioners and for the occasional reimbursement of their costs were further explained by the secretariat.
3. The EPP suggested that PETI should have an enhanced role according to article 50 of the Rules of Procedure in drafting Parliament's opinion on the Draft Regulation for the Citizens' Initiative. The Chair will write to the Conference of Committee Chairs in this respect. A decision on the rapporteurs will be taken at the next meeting.  
Meanwhile the groups were invited to designate a rapporteur for opinion on Regulation 1049 Access to Documents at the next coordinators' meeting.
4. Delegations  
**Campania:** The Chair informed members that she had received a letter from the Italian Permanent Representation to the EU suggesting a possible postponement of the mission. The Chairwoman undertook to consult the members of the delegation to seek their views on the matter before responding.  
**Austria:** The groups were invited to designate two additional members to Mr Wieland, designated by the EPP, who will lead the delegation. The S&D group designated Ms Iotova.  
**Greece:** Members agreed that a fact-finding mission should be requested, although it was unlikely for this mission to be scheduled before the summer.
5. Any other business  
**Nordstream:** It was agreed, on a proposal from the S&D Group, that Ms Lidia Joanna Geringer de Oedenberg should have responsibility for ensuring the follow-up to the Libicki Report. The President of the Parliament and Mr Libicki are to be informed

accordingly.

Decision: Request President Buzek to write a letter to the Spanish Prime Minister, highlighting, inter alia, the arbitrary application of the law, the lack of legal certainty, unfair compensation. Write a letter to Commissioner Viviane Reding asking for clarification on the aspects of petitions related to the Charter of Fundamental Rights and the ECHR. The coordinators will discuss other possible follow-up measures.

Decision: The Chairman should write to the Irish Minister of Environment, John Gormley seeking clarifications concerning the waste management in the area and the assessment of the risks posed by the planned landfill to the existing aquifer and to the local horticulture activities; the European Commission should also provide information on the implications of the approval of the landfill from the perspective of the Water Framework Directive and Drinking Water Directive, as well as on the compatibility of the Irish waste management policy with the EC legislation; it should also present the measures taken to have Ireland enforce a recent ruling by the ECJ against it in relation to the access to justice. The Commission is asked to visit Ireland on this matter.
