IV. Appearance of Ministers responsible for the Cohesion Policy before the Committee

It is proposed to proceed with such meetings by inviting the Rumanian Minister and then following on with other Member State's Ministers in accordance with their availability and the relevance of the country for EU regional policy. The coordinators could of course send the secretariat their priorities if they wish so.

V. Oral questions on the field of Regional and Cohesion Policy. A Committee Strategy

1) It is decided that when a political group decides to present an oral question, the Secretariat will be informed as soon as possible with a view to check whether it is feasible/convenient to transform the political group oral question into REGI committee oral question.

2) On Mr Lambert van Nistelrooij proposal, the coordinators agreed by unanimity to support the EPP oral question on the Danube Strategy at the CoP.

VI. Non-legislative reports. Time of drafting: an evaluation

It was agreed that after four months without activity from an appointed Rapporteur, the Secretariat will inform the coordinators.

It was also decided that after a reasonable period of inactivity the coordinators will look with their Members the reasons of this lack of initiatives.
