**7. Chairperson's announcements concerning coordinators' decisions**

- **First railway package**

The Coordinators discussed on the ongoing negotiations concerning the recast of the first railway package, after the Rapporteur presented them the state of play of the work achieved and to be done. Some groups suggested that the issues of opening of the domestic markets and of the unbundling of infrastructure management and of transport activities could be put aside while others and the Rapporteur insisted on the need to keep political pressure on the Commission in order to come forward with new proposals on these two issues. Different solutions will be discussed at the upcoming meetings of the Rapporteur with the Shadow Rapporteurs.

- **Comitology**

The final draft measures on pilot licences and security scanners were received in July - the 3 month period for Parliament to veto will finish in October.

The Coordinators heard the Commission representative on pilot licences.

Within the deadline for objections (30 August) draft motions for a resolution to object to these measures were introduced. The Coordinators agreed to put these draft resolutions to the vote at the TRAN Committee meeting on 31 August.

### **Interparliamentary activities of committees**

The Conference of Committee Chairs asked each committee to draw up a list of interparliamentary activities with national parliaments for 2012 in its October meeting.

In principle, it is possible to organise a full committee meeting with attendance of representatives of national parliaments on a politically high profile topic. The other option would be to cooperate for concrete legislative files on the level of Rapporteurs of the national parliaments. Topics for possible consideration might be the airport package or rail market access.
