*The meeting opened at 15.30 on Thursday, 19 March 2015, with Charles Goerens (EP Co-Chair) presiding.*

The Co-Chair announced the language regime.

**1. Adoption of agenda**

**2. Approval of minutes of the meeting of Saturday 29 November 2014 in Strasbourg**

**3. Co-chairs' announcements**

Members took note that the Vanuatuan authorities had informed the Bureau of the ACP Assembly that it would not be possible for them to host the 29th session of the ACP-EU JPA in Port Vila in June 2015, due to the damage caused by cyclone Pam.

One minute of silence was held in memory of the victims of the disaster.

The Co-Chair informed the Committee that the Bureau had decided the following for the 29th Session to be held from 17 to 19 June 2015 in an ACP country (tbc):

Topics for urgent motions for resolution:

1. The natural disaster in Vanuatu (and neighbouring states): the way forward including regional cooperation
2. The situation in the Central African Republic

The deadline for tabling urgent motions for resolution is 5 May 2015 at noon.

Keynote debate:

Seas/Oceans (in case the session takes places in the Pacific region)

Topics for debate without resolution:

1. Natural resources
2. Improving internal revenue generation capabilities within ACP states

The deadline for submitting questions for oral answer to the Commission and Council is Friday 27 March 2015 at noon.

**7. Irregular migration and trafficking in human beings and human rights**

- Presentation by Irina Todorova, Regional Migrant Assistance Specialist, International Organisation for Migration, Regional Office in Brussels

Irina Todorova introduced the activities of the International Organisation for Migration and gave an overview of the global migration trends, with a focus on the anti-trafficking response and a possible role of Parliaments.

Members insisted on addressing the root causes of irregular migration, in particular inequality, resources allocation, political instability, poor conditions with regard to health, education and employment in the countries of origin and the failure of certain control aspects with regard to employment and housing conditions in the countries of destination.
