The project aims to put into practice the European legal framework that is currently supporting the development of a family based care initiatives but is still lacking of significant initiatives for real implementation as well as explore other innovative initiatives.

The Pilot Project aims to provide a residential service in which the family of the child or adolescent has a relevant role. The services would promote the change in the structure of the family and thus allow the return of the child / adolescent in the family group as soon as possible thanks to the empowerment of children and their families and through networking initiatives to achieve their social integration. Due to its characteristics, these services should be valued as a pre alternative to a regular care institution. The project would implement in different residential places across Europe, children and adolescents care services that follow a family based care model. As a relevant project element, intense advocacy activities will be also undertaken by the project partners in their countries to disseminate the project to relevant stakeholders and decision makers in order to promote the adoption of the project model into the regular services provided by children welfare authorities in a near future.

The project also aims to provide families and children who are at risk a residential place, with the focus in the return of the child/adolescent to the family with the least time possible. This will be done thanks to the empowerment of children and families and through networking to achieve social integration. Intervention lines:

- Family work. A comprehensive child and family intervention is developed. The intervention will focus on stimulating relational aspects and the capacities of families.
- Specialized Intervention. Transversally, all children and their families attended by the service may benefit from complementary support such as social, psychological and pedagogical support. This will be materialized through activities such as individual tutoring, family counseling, individual support on parental roles, guided sessions on family dynamics, daily task management

Pilot project — The reduction of youth unemployment and the setup of co-operatives as a measure to enhance working opportunities in the EU

Remarks:

Add following text:

In the EU two groups currently affected by unemployment have huge potential; young people and those with higher education. These groups could create jobs in the EU by working in the co-operatives which they also own but to do so they need guidance and support in the form of labour market training.

Worker co-operatives act as an economically feasible way to start entrepreneurship, and due to their communality as well as shared opportunities and obligations, they are a low risk way for participants to both work and own part of the company simultaneously. Participants will establish new worker co-operatives, combining individuals' special skills and knowledge to their common benefit and advantage. These co-operatives have a good chance to offer sustainable jobs to their owners/employees as these companies have a competitive advantage compared to most other kinds of companies due to their low general costs. The pilot project is planned to be launched in three different EU countries with the most experience in this field.

The main objective is to contribute to reducing youth unemployment by establishing best practice in the area for the whole of Europe. The scheme of the pilot project would be as follows:

- 1. Preliminary actions and set-up of the programme in three different countries (1st year):
- 2. Development and realization of the training courses (1st and 2nd year);
- 3. Follow-up of and setting up of co-operatives with target groups (2nd and 3rd year);
- 4. Evaluation of legal business barriers by experts (3rd year);
- 5. Evaluation of the results (3rd year); and
- 6. Report of the results, including the proposition of possible following operational activities (3rd year).

The overall financing of the pilot project could be scheduled as follows:

- 600 000 euros per year 2016
- 800 000 euros per year 2017
- 500 000 euros per year 2018

Pilot project — Green Graduates for a Sustainable Future

Remarks:

To tackle youth unemployment and under-employment, releasing the potential of the green economy, allowing SME's to innovate, create and grow.

A programme of paid graduate sustainability placements, uniquely focused on job creation, enabling participants to learn about sustainability in the context of the 'real world', while applying and building on skills and knowledge acquired through their university experience. The placements will provide work opportunities to participants with diverse skills-sets and across disciplines, providing an outlet for graduates interested in sustainability and keen to apply their skills and knowledge gained through university study to make a positive and tangible impact.

The development of knowledge and professional skills required for employment in the global environmental job market will be a critical asset for future careers in the low carbon and sustainable economy. Increasingly, employers demand that incoming employees demonstrate a greater understanding of the social, economic and environmental aspects of their work, so as to contribute to improved environmental performance, efficiency, innovation and business opportunities.

Through coordinated graduate placements, graduates get the opportunity to prove themselves, and utilise their leading-edge knowledge and understanding, and employers get a fresh pair of eyes that can provides new insights and ways of thinking on sustainability and climate change.

Building on successful models

There is an excellent opportunity to test and scale and replicate successful models of co-ordinated development of graduate placements, recruitment, induction, training, support and employment. Successful models already up and running in some member States provide organisations, predominantly SMEs, with the support, capacity and resources needed to access the graduate talent pool particularly around recruitment, selection and ongoing training for the graduates. It provides a low risk way of harnessing the potential of the graduate labour market and creates new jobs.

Similar models, such as that of Change Agents UK and the Zukunftspiloten Programme in Germany, have seen a high proportion of post project employability with many graduate placements leading onto further employment opportunities, both in the UK and across Europe.

In addition to supporting job creation, successful programmes also complement the mobility of young

people within and across European member states.

Change Agents UK works with organisations to create green placements for recent graduates, and places more than 200 graduates a year in paid or funded work placements in the UK. The success of the programme has resulted in it being used by the National Agency (Ecorys) as a flagship case study in best practice for Mobility projects (www.uk.ecorys.com/news/november-2013/14nov13.html),

Preparatory action — Towards asbestos-free workplaces in the EU

Remarks:

Add following text:

Asbestos is one of the most important occupational carcinogens, causing about half of the deaths from occupational cancer.

About 125 million people in the world are exposed to asbestos at the workplace. According to WHO estimates, more than 107 000 deaths each year are attributable to occupational exposure to asbestos.

There are some 3000 recorded uses of asbestos including "fireproof" textiles, paper and boards, clutch and brake linings, asbestos cement sheets and pipes, flooring and roofing products, electrical and thermal insulating materials, coatings and heat shields. Asbestos fibres can be spun into yarn and made into textiles.

Often asbestos was a component of roof tiles, in cars it could be found in brakes or as insulation fibre. Asbestos was a commonly used filtration material for every type of liquids - from beer to chemicals. It was even used in protective equipment. Technical fire protection was often done with asbestos.

In Europe the use of asbestos is banned, however, workers can be exposed to asbestos during asbestos removal, or accidentally, during maintenance and demolition activities. There are strict regulations on the prevention measures during asbestos removal, thus accidental exposure can be far more risky as the danger is not realised.

Asbestos can still be found in:

Industrial buildings

Private homes

Ships

Heating or cooling systems

Work equipment and plant

This preparatory action is intended to foster the implementation of Directive 2009/148/EC on the protection of workers from the risks related to exposure to asbestos at work and to follow up of the European Parliament resolution of 14 March 2013 on asbestos related occupational health threats (2012/2065(INI)).

Links with priorities and policy or legislative initiatives at EU level

Health and safety at work

The preparatory action would provide for the swift implementation of the recommendations of the EMPL report on asbestos related occupational health threats and prospects for abolishing all existing asbestos (2012/2065(INI)) adopted in plenary on 14th March 2013.

It would contribute to the proper implementation of Directive 2009/148/EC of the European Parliament and of the Council of 30 November 2009 on the protection of workers from the risks related to exposure to

asbestos at work.

The preparatory action would also feed into the 2014-2020 EU Health and safety strategy, which confirms that diseases caused by asbestos need continued specific attention.

Actions / measures to be funded

Measures covered should include:

a report on implementation of Directive 2009/148/EC in Member States, highlighting best practices in Member States which have already implemented compulsory screening schemes with specific recommendations to increase the efficiency of such schemes;

based on the report, the design of a method for screening and registering asbestos in workplaces in view of a later screening of those buildings;

an impact assessment and cost benefit analysis of the possibility of establishing action plans for the safe removal of asbestos from workplaces, with particular attention to buildings providing services which require regular public access;

This preparatory action could also cover:

the design of EU models for public asbestos registers which would serve to provide relevant information on asbestos risks to workers and employers prior to renovation work being undertaken;

a public awareness campaign to encourage employers to effectively audit and risk assess their premises for asbestos-containing materials;

a public awareness campaign on asbestos-related risks and the detailed occurrence of asbestos;

developing appropriate training and safe working procedures for workers likely to be exposed to ACMs (construction workers; miner; car mechanics; shipping, etc.)

the setting up of an EU network of occupational asbestos victims, providing them with updated information on available medical care and support and legal litigation.

Preparatory action — European Networks Providing Facilities For Labour Integration of Third Country Nationals and Their Families

Remarks:

Add following text:

Until today actions aiming for labour-integration of migrants have been limited to EU-mobile workers and intra-EU posting of workers. Third-Country nationals represent more than 60% of the migrant working population and doomed to increase in the following years. Resources should be delivered to help European coordinated integration strategies for third-country nationals based on access to information, regular stay and employment of third country nationals, support to intra-EU mobility of third country nationals, portability of qualifications acquired on the labour-market in the hosting country.

A preparatory action will be financed for wrapping benefits of enhanced cross-border cooperation in networks of contact points for migrant workers established by social partners providing information/assistance/integration facilities for third-country nationals and their families settled in the territory of a member states. The preparatory action should have as a result:

- centers of excellence for a correct implementation of the EU acquis on migration and labour-mobility of third country nationals.
- a platform connecting contact points to support intra-EU mobility of third-country migrant workers
- a platform to ensure intra-EU portability of qualifications of third-country nationals acquired on local labour markets
- facilities for pre-departure information to third-country nationals
- regular exchanges and multiplying of best practices for labour-integration of third-country nationals

In order to ensure the deepest and long-standing impact for the benefit of third-country nationals the preparatory action should be accessible to networks established by trade unions and/or employer associations that have the following features:

- networks providing assistance for integration of third country nationals in at least 10 member states
- networks composed by organisations with a well-rooted presence on the territory in at least 10 EU member states

- o Associations of third-country nationals
- o Membership based organisations whose membership is open to third-country nationals
- o Organisations whose mission is to provide facilities for integration to migrants
