## **12. Chair's announcements concerning coordinators' decisions**

- The coordinators appointed Heidi Hautala as rapporteur for opinion on protecting against the effects of the extra-territorial application of legislation adopted by a third country and actions based thereon or resulting therefrom;
- The coordinators appointed the Chair as the rapporteur for opinion on the authorisation for Austria, Belgium and Poland to ratify, or to accede to, the Budapest Convention on the Contract for the Carriage of Goods by Inland Waterways (CMNI);
- The coordinators appointed Mr. Dzhambazki as the rapporteur for opinion on Towards a Connected Digital Single Market Act;
- The coordinators approved the programmes of hearings for the second half of 2015 as follows:

- Review of the interinstitutional agreement on better law-making;
- Review of the Brussels II Regulation.
- The coordinators agreed to the draft calendar of committee visits for the second half of 2015;
- The coordinators took note of the motion for resolution on setting up a register of fake Italian agri-food products sold in the EU and third countries;
- The Chair was appointed rapporteur for the 2016 Budget ;

- The coordinators agreed to invite the Legal Service to present its work on monitoring EC proposals for legislative acts as regards quality of drafting legislation and better law-making;
- The coordinators appointed Ms Hautala, as standing rapporteur, the committee's representative on the Inter-committee network on the implementation of the UN Convention on the Rights of Persons with Disabilities;
- The coordinators agreed to invite Mrs Farida Shaheed, the UN Special Rapporteur on Copyright Policy and the Right to Science and Culture to address the Committee by videolink on 6 or 7 May 2015.
- The coordinators instructed the Secretariat to get the agenda of future meetings of the Commission's expert group with Member States on IPR enforcement and ensure a Member of the Secretariat attends future meetings and report back to coordinators.
- An informal meeting with the Council, the Commission and the Court of Justice cannot be held during the next Strasbourg session but it will be scheduled as soon as possible after the shadows meeting in Strasbourg, as the next steps to be taken will be decided at the shadows' meeting (in consultation with the Coordinators).
