# Note for the attention of Ms Cecilia WIKSTRÖM Chair of the Committee on Petitions

Subject: List 3 of petitions considered potentially non-compliant with the provisions

of art 227 TFEU

In accordance with the new operational instructions as regards the administration of petitions, you will find enclosed the List 3 of petitions which are considered to be potentially non-compliant with the provisions of art. 227 TFEU.

As they have been formally entered in the register, you will also find them on the List 1, which has been sent to you separately.

These petitions, registered in GEDA under the code «LISTE 3», are classified under the following categories:

- 1) Matter seemingly not coming within the Union's fields of activity;
- 2) Lack of substantial elements enabling the identification of the Union's fields of activity;
- 3) Incoherent reasoning with an unclear link to the Union's fields of activity.

Other categories could be added in the future, should other typologies of potential cases come to light.

The Secretariat of the Committee on Petitions is informed in real-time about this classification via an individual GEDA notification.

It should be emphasized that this categorisation of petitions falling under this list is only a suggestion from my services. The sole purpose is to alert the Secretariat of the Committee you chair, to petitions which could be treated with a curtailed procedure.

List 3 of petitions considered potentially non-compliant with art. 227 TFUE under the new operational instructions for the administration of petitions, and also included on List 1 of petitions received and entered in the register, which have been forwarded by the President of the European Parliament to the responsible Committee, in compliance with the provisions of rule 215 of the Rules of Procedure (petitions from 2463-14 to 2579-14).
