*The meeting opened at 15.15 on Monday, 26 January 2015, with Cecilia Wikström (Chair) presiding.*

## **11. Chairman's announcements concerning Coordinators' decisions**

### **1) Draft agenda:**

The Draft Agenda for 26 February 2015 was approved by the coordinators.

### **2) Appointment of drafts person for opinion**

- a) Opinion to the INTA report on the EU-US trade agreement (Transatlantic Trade and Investment Partnership - TTIP).

Mr. Jarosław Wałęsa (EPP) was appointed as a drafts person for the Opinion.

It was accepted that the Opinion should make reference to all petitions received on this subject.

- b) Opinion to the Report "A Follow up to the European Citizens' Initiative Right2Water 2014/2239(INI)"

The Greens/European Free Alliance will appoint a drafts person.

### **3) Appointment of a member for the structures implementing of UN Convention on the Rights of Persons with Disabilities**

Ms Rosa Estaràs Ferragut (EPP) and Ms Soledad Cabezón Ruiz (S&D) were both appointed as members representing the PETI Committee at the structures implementing of UN Convention on the Rights of Persons with Disabilities.

### **4) Contested recommendations**

### **5) Request for the urgency procedure**

It was decided to treat the petition 1004/2014 under the fast-track procedure, as requested by Mr. Peter Jahr (EPP). It was agreed that the item could be put on the April Agenda of the PETI Committee.

#### **6) Requests by the Groups:**

Members took note of the proposals raised by Ms Rikke Karlsson (ECR) and decided to reconsider those following the hearing organised by the JURI Committee on 26 February 2015 "*Cross-border activities in the EU - Making life easier for citizens*" where related issues will be raised, and after the Study prepared by the Policy Department C will be presented.

#### **7) Any other business.**

The Chair informed Coordinators about the request put forward by Marian Harkin and Nessa Childers to re-open the petition 1660/2013 which had been closed by the Committee. Following opinions expressed by the members it was unanimously decided to keep it closed.

As for public hearings and future fact finding visits it was decided to come back to this at the next coordinators' meeting.

#### **8) Items for information**

The coordinators took note of the following:

##### **a) Updated draft agenda for the ECI hearing (26 February 2015)**

###### *Background information:*

The hearing will be jointly organized by the AFCO and PETI Committees and will feed into the implementation report due to be drafted by the AFCO Committee, in association with PETI under Rule 54 of the Rules of Procedure. The Secretariat circulated the draft agenda, which was adopted by written procedure in the two committees on Wednesday 21 January.

##### **b) List 3 (possibly inadmissible petitions)**

The first list of registered petitions considered by DG Presidency as being potentially non-compliant with the provisions of the art 227 TFEU was circulated to all Members on 5 December 2014, with a deadline for comments on 12 December 2014. Several requests have been received to remove certain petitions from the list and to summarise them under the normal procedure (eg. 2165-14 and 2167-14, at the request of Notis Marias).

A second list was forwarded on 12 December 2014 and a third list on 8 January 2015.

##### **c) Balayage exercise - second phase**

In the second phase of the balayage exercise, the secretariat provided the members with a special list of all open petitions that have been registered before 1/1/2013, excluding the petitions covered in the list in the first exercise (approximately 630 petitions). The list includes recommendations on whether to close the petitions (B) or whether to keep them open (P). A meeting of the Secretariat and the political groups will take place shortly. The list including any proposals for amendments will be decided during an extraordinary coordinators meeting (date to be determined).

- d) Commission Vice-President Mr. Frans Timmermans will attend a PETI Committee meeting in April or May.
- e) A delegation from the Bundestag will attend the PETI Committee meeting on 4 May 2015 in the afternoon.
- f) Information concerning cases C-261/13 Schönberger/Parliament and T-168/11.
- g) Draft agenda of the Gender Mainstreaming Network (15 January 2015). PETI is represented in the network by EPP Coordinator Peter Jahr.
- h) The "Civil law and justice forum" will take place on Thursday, 26 February 2015 in Room ASP 5 G 2 and is organized by Policy Department C for the Committee on Legal Affairs.

The afternoon session will start with an item that is particular relevant in the context of petitions: Cross border families and families crossing-borders. Ms Mairead McGuinness, European Parliament Mediator for parental child abduction, features among the keynote speakers and the session will include a presentation of the study: "Cross-border parental child abduction".

In 2014, a total number of 127 petitioners attended committee meetings and a total of 21 petitioners and experts received reimbursement for the travel expenses.
