### Debate on Paris attacks and anti-terror measures

MEPs will discuss the 13 November terrorist attacks in Paris and subsequent police and military operations, and also give their feedback on the 20 November Justice and Home Affairs Council meeting, in a key debate with Commission President Jean-Claude Juncker and Nicolas Schmit, representing the Council Presidency on Wednesday from 8.30 to 12.00.

A resolution on preventing radicalisation and recruitment of EU citizens by terrorist organisations will also be debated on Tuesday afternoon and voted on Wednesday.

The debate is set to focus on current and envisaged anti-terror measures. These include the Passenger Name Record data (EU PNR) proposal (currently being negotiated in three-way "trialogue" talks between Parliament, Council and Commission), stepping up information-sharing among EU member states and between them and Europol, strengthening controls at the EU's external borders, tackling terrorist financing, and combating firearms trafficking.

Ways to counter Daesh in Syria and elsewhere are also expected to be addressed in the debate.

# Fighting radicalisation of young Europeans without undermining citizens' rights

Member states should step up cooperation and swift exchange of information between national law enforcement bodies and EUROPOL to detect and monitor terrorist suspects or potential "foreign fighters", MEPs say. In a draft resolution to be discussed on Tuesday afternoon and voted on Wednesday, they also recommend measures such as prompt deletion of illegal content that spreads violent extremism on the internet.

In this non-binding resolution, MEPs give their input for a joint EU strategy for fighting extremism and the recruitment of EU citizens by terrorist organisations, to be applied in particular online, in prisons and through education and social inclusion.

Other measures include confiscating passports, freezing financial assets, checking potentially radicalised people re-entering the EU, and setting up a blacklist of European jihadists and jihadist terrorist suspects.

MEPs will also recommend separating radicalised prisoners, strengthening intercultural dialogue and setting up support systems such as hotlines where family members and friends can get help quickly if they fear someone is being radicalised or may be about to leave the EU to join a terrorist organisation.

#### Note for editors

An estimated 5,000 European citizens have joined terrorist organisations and other military formations, particularly ISIS, Jahbat al-Nusra and others in the Middle East and North Africa.

# Vote on recommendations to end aggressive tax planning and tax evasion

Parliament's recommendations to combat aggressive corporate tax planning and tax evasion will be debated on Tuesday, and set out in a resolution to be voted on Wednesday. They will include requiring multinational firms to report their financial data country by country, introducing a common consolidated corporate tax base, making EU member states' tax deals with these firms more transparent and doing more to protect whistle blowers.

The draft resolution, prepared by co-rapporteurs Elisa Ferreira (S&D, PT) and Michael Theurer (ALDE, DE) builds on the principle that multinational companies should pay their taxes where value is created.

They argue that today's corporate tax competition – prompting aggressive tax planning and evasion, without any agreed framework - is harmful. Apart from the loss of public revenue, it is unfair that big firms should pay hardly any taxes on their profits, while small and medium-sized ones – and citizens - must pay their full share.

### **EU budget 2016: final vote**

Parliament will vote on Wednesday the EU budget for 2016, following a compromise deal between Parliament and Council. Parliament negotiators reversed most of the cuts made earlier by the Council and negotiated more funding for migration front-line countries, humanitarian aid, the EU research and development tool Horizon 2020, small and medium-sized enterprises and students on Erasmus+ exchange programmes.

Parliament and Council agreed on €155 billion in commitment appropriations and €143.9 billion in payment appropriations for 2016. The agreement on the 2016 budget – part of an overall deal reached on 14 November – includes pledges to continue with the youth employment initiative and to keep the level of unpaid bills low. Council is expected to confirm the joint conclusion of the negotiations on 24 November.

# Parliament to push for maximum EU funding to tackle refugee crisis

The EP will call on Wednesday on member states to stump up as much money as possible to tackle the migration crisis. It wants cash saved from smaller than expected EU budget contributions to go to two EU funds to help refugees and migrants in and near Syria and to tackle the root causes of migration in Africa. MEPs are also to decide on the use of a maximum budget flexibility to provide additional resources for migration management efforts.

While member states' contributions to the EU budget have fallen by €9.4 billion, partly thanks to a windfall of €2.3 billion in competition fines and higher than expected customs duties, their financial pledges to the Africa Trust Fund and the Syria Trust Fund are still behind by €2.3 billion. Parliament expects member states to honour their pledges, states the draft resolution on draft amending budget 8/2015.

In a separate vote on Wednesday, the House is set to approve the use of budget flexibility to finance migration. It successfully negotiated a deal to make full use of the €1.53 billion available from the 2014 and 2015 budgets for this purpose in 2016.

# EP secures better information, advice and protection for insurance buyers

Buying insurance will be made easier and safer following Parliament's vote on Tuesday to update EU rules on the information and advice offered by insurance sales staff. The current rules on sales of insurance will be amended to introduce similar information and consumer protection requirements for all insurance distribution channels unless they meet the conditions for exemption.

Insurance distributors will have to register with a competent authority in their home member state, and their sales staff will have to be fully trained to meet the requests and needs of customers. Buyers must be informed of the overall cost of the insurance contract and, before signing it, must be given standard information, free of charge, on the type of insurance, obligations under the contract, risks insured and excluded and means of payment and premiums, in clear, plain language.

To protect clients against the financial inability of an insurance distributor to pay out a premium or a claim, intermediaries (brokers or sellers) must have a permanent financial capacity amounting to 4% of the sum of all annual premiums received but no less than €18,750.

The rules will not apply to all insurance distribution. There are exemptions, for example when the insurance is complementary to the supply of goods or services and covers the risk of damage or theft, or when the amount of the premium paid for the insurance product does not exceed €600 calculated on an annual basis.

## Stop violence against women: EP in orange on 25 November

On Wednesday, 25 November, the International Day for the Elimination of Violence against Women, MEPs will ask the European Commission what new measures it plans to take to prevent gender-based violence against women in the EU and whether it can propose an EU directive on combating violence against women, as requested by Parliament. The debate starts at 15.00.

To mark this day, the European Parliament in Strasbourg will participate in the global initiative "Orange the world" and the building will be lit up in orange from the evening of 24 November until until midnight on 25 November.

"Orange the world" is a yearly UN campaign to prevent and end violence against women and girls. This initiative aims to raise awareness and promote action to end violence against women. It will run for 16 days, from 25 November to 10 December.

### Background for editors

In February 2014 Parliament passed a legislative initiative resolution calling on the Commission to propose an EU-wide strategy to this end; including a draft law with binding instruments to protect women from violence.

In May 2014 the former Commission replied that it did not consider it appropriate to table a legislative proposal on prevention measures to combat violence against women.

According to the EU Fundamental Rights Agency survey, one third of women in the EU have experienced physical and/or sexual violence since the age of 15. That corresponds to 62 million women.

# Debate on ways to protect and support the EU base metals and steel industry

Anti-dumping measures and sustainable initiatives to support the European base metals industry, including steel, will be debated with the Commission on Tuesday afternoon. A draft resolution prepared by Edouard Martin (S&D, FR) is scheduled for a plenary vote in December.

Industry Committee MEPs call for "the revision of the two regulations on trade defence instruments (TDI)", and suggest "an initial review of anti-dumping and anti-subsidy complaints".

They also deplore "the fact that the legislative proposal on the modernisation of TDI is at a standstill in the Council despite the strong support which Parliament has expressed for tougher measures against unfair imports from third countries".

### Concerns over toxic additive to recycled plastics

The EU Commission should not authorise the recycling of plastics that contain the banned softener diethylhexyl phthalate (DHEP), to make soft PVC items such as footwear and floor coverings, because it poses a reproductive toxicity threat to exposed workers and could render their male foetuses sterile, says a draft resolution to be voted on Wednesday.

DEHP has been the main "general purpose" phthalate used over the last 50 years. Under the REACH legislation, DEHP has been classified as a Substance of Very High Concern and since February 2015 authorisation for its use must be granted by the European Chemicals Agency (ECHA). The use of DEHP is also banned in toys, childcare articles and in cosmetics.

The Commission has proposed, in a draft decision still to be approved by EU member states, to authorise the recycling of old plastics containing it into new PVC products.

DEHP is known to adversely affect the endocrine system in mammals, e.g. by reducing foetal testosterone. It can also irreversibly affect the rate at which a mammal develops as well as its reproductive capacity, says the text.

# MEPs ask to increase support for children's access to education in emergencies

MEPs will debate the need for member states to support the Commission's target of increasing the share of humanitarian funds for the education of children in emergencies to 4% and for all host countries to help integrate child refugees in their national education systems on Wednesday afternoon, and vote on a resolution on Thursday.

Note to editors

It is estimated that 65 million children are affected by emergencies and protracted crises in 35 countries and that approximately 37 million primary and lower secondary age children are out of school in crisis affected countries. However, education in emergencies is the most underfunded sector, with only two percent of humanitarian aid catering for these needs.

## Parliament to state its position for world trade talks in Nairobi

The European Parliament's political message for the December round of world trade talks in Nairobi (Kenya) will be debated on Monday and voted on Tuesday. ## Child poverty: MEPs to table recommendations to break the vicious circle

Recommendations to break the cycle of disadvantage for children living in poverty will be set out in a resolution to be debated on Monday and voted on Tuesday. They include investing more in social protection, health, education and social housing, and establishing "child guarantee" funds for this purpose.

The text, drafted by Inês Cristina Zuber (GUE/NGL, PT), also calls on the EU Commission and member states to step up resources, services and also children's participation, to fight child poverty. Reducing child poverty and social exclusion should also become a sub-target of the EU 2020 Strategy, it adds.

Background for editors

Between 2008 and 2012, the number of children at risk of poverty or social exclusion in Europe (EU27+Norway, Iceland and Switzerland) rose by almost one million, increasing by half a million between 2011 and 2012 alone. In 2013, 26.5 million children in the EU28 were at risk of falling into poverty or social exclusion. In Estonia, Greece and Italy, the percentage of children who cannot eat meat, chicken or fish two days running has doubled since 2008 (Eurostat data).
