### 100th anniversary of the Armenian genocide

## A European Parliament resolution marking the 100th anniversary of the Armenian genocide will be voted on Wednesday afternoon, following a debate.

The European Parliament was the first major international organization to recognize the Armenian genocide in a resolution voted in 1987. It has also called upon the Turkish government to do likewise, in a score of resolutions on EU-Turkey relations.

A day of remembrance to mark the Armenian genocide is held every year on 24 April.

## MEPs to call for end to discrimination and hate crime against Roma people

Parliament is likely to request further efforts to put an end to discrimination, hate crime and hate speech against Roma people and to call on the EU to recoginse 2 August as the Roma Genocide Remembrance Day, in commemoration of the Roma genocide in World War II, in a resolution to be voted on Wednesday. The resolution will wind up the debate held on 25 March. International Roma Day was celebrated on 8 April.

Roma people are Europe's largest ethnic minority. Some 10 to 12 million are estimated to live in Europe, including around six million in the EU.

Roma Genocide Remembrance Day on 2 August seeks to raise awareness of the extermination of Roma people by the Nazis during the Second World War and of past and present hate crime and speech directed against them.

## Vote on carry-over of EU funding to 2015 for latestarter national programmes

Proposed changes to ceilings within the EU's 2014-2017 budget will be debated on Wednesday at 15.00 and put to a vote at about 18:30. These changes would allow €21.1 billion in unused commitment appropriations to be carried over from 2014 to 2015-17, to help fund member statemanaged programmes that started late.

The changes were requested by the European Commission, and have been informally and unanimously approved by the Council of Ministers. Parliament can either give its assent to the Council text or reject it.

If the ceilings are changed as proposed,, the first tranche of €21.1 billion can be transferred to 2015 through a draft amending budget (DAB2/2015), adding €16.5 billion to the commitment appropriations available for 2015.

The remaining tranches, of €4.5 billion for 2016 and €100 million for 2017, are to be handled in separate draft amending budgets. For further details on the uncommitted appropriations, read the EP backgrounder.
