### Parliament to elect its new President, Vice-Presidents and Quaestors

MEPs will cast their votes to choose the new President of the European Parliament for the next two and a half years. After three-minute presentations by each candidate on Tuesday at 9.00, the secret ballots will be chaired by outgoing President Martin Schulz.

Seven official candidates from different political groups are so far declared for Parliament's top position. Fresh candidatures could emerge before any of the first three ballots. If no candidate wins an absolute majority of valid votes cast during the three first ballots, the President will be elected by a simple majority in a fourth and last ballot between the two candidates who scored best in the third ballot.

At the time of writing, the declared candidates were:

- Eleonora Forenza, European United Left-Nordic Green Left Group (IT),
- Jean Lambert, Group of the Greens/European Free Alliance (UK),
- Gianni Pittella, Progressive Alliance of Socialists and Democrats Group (IT),
- Laurenţiu Rebega, Europe of Nations and Freedom Group (RO),
- Helga Stevens, European Conservatives and Reformists Group (BE),
- Antonio Tajani, European People's Party Group (IT), and
- Guy Verhofstadt, Group of the Alliance of Liberals and Democrats for Europe (BE)

#### 14 Vice-presidents, 5 Quaestors, 22 Committees

On Wednesday, MEPs will elect Parliament's 14 Vice-Presidents and five Quaestors in secret votes, chaired by the newly-elected President. They will also approve the numerical composition of Parliament's 22 standing committees. On Thursday at noon, MEPs will vote on the appointments of members to committees.

# MEPs set to return EU Commission blacklist of states at risk of money laundering

MEPs may decide that the EU Commission must revise its blacklist of countries deemed to be at risk of money laundering and terrorist financing. A draft resolution to be voted on Thursday argues that this list is too limited, and should be expanded, e.g. to include territories that facilitate tax crimes.

The Commission lists eleven countries, including Afghanistan, Iraq, Bosnia and Herzegovina, and Syria, which it judges to be deficient in countering money laundering and terrorist financing. People and legal entities from blacklisted countries face tougher than usual checks when doing business in the EU.

If MEPs vote to return the list to the Commission, an existing inventory of third countries thought to fall short in this area will remain in force while the Commission considers any revisions.

# Debate with Messrs Katainen and Tusk on EU summit outcome and challenges in 2017

## Welfare state: MEPs to call for "EU core" of social rights for all

The forthcoming "European Pillar of Social Rights" (EPSR), announced in 2015, should not just be a statement of good intentions. It must include concrete proposals to reduce inequality and poverty in the EU, says a draft resolution to be debated and voted on Thursday. The EU Commission should also prepare a law guaranteeing every worker a core set of rights, such as equal treatment, health and safety protection, and parental leave, it adds.

The text, drafted by Maria João Rodrigues (S&D, PT), notes that the EPSR, as a review and update of the so called "European Social Model", should enable people to live a dignified life by safeguarding the principles of equal treatment, non-discrimination and equal opportunities. The new instrument should also ensure that international labour standards are properly applied in all member states, which is not always the case, it adds.

The draft resolution also calls for decent pay for internships, at least covering basic expenses and clarification of whether a person working for a digital platform is really self-employed or is in an employment relationship which entails a set of rights and obligations. It also suggests introducing a European social security card with a record of individual contributions to social security systems wherever a person has been employed.

## Sharing intelligence on terror attacks - debate with Council and Commission

Recent terror attacks in the EU have highlighted deficiencies in the sharing of law enforcement and intelligence information among EU member states. On Wednesday evening MEPs will quiz the Council and Commission on their plans to ensure that vital information is exchanged quickly and update legislation to this end.

Parliament has repeatedly stressed the need to ensure smooth information exchanges between EU countries' law enforcement authorities to strengthen the collective fight against terrorism, a field which until the Lisbon treaty was an exclusive competence of the member states.
