Review of Austrian presidency and debate on Romanian priorities on Tuesday

MEPs will discuss priorities of the incoming Romanian Council presidency with Prime Minister Dăncilă at 15:00, following a morning debate with Austrian Chancellor Kurz.

In a debate with the Austrian Chancellor Sebastian Kurz at 10.30, Parliament and EU Commission President Jean-Claude Juncker will assess the Council presidency's achievements over the past six months and discuss progress made on long-term budget negotiations.

Prime Minister Viorica Dăncilă will present the priorities of the incoming Romanian presidency at 15.00, focussed on cohesion and common values, safety and strengthening Europe as a global player.

A press conference by EP President Antonio Tajani and Prime Minister Dăncilă is scheduled at 17.00.

European Elections will be held 23-26 May, one month before Romania hands over the rotating Council presidency to Finland.

MEPs to debate EU summit and reform of EU asylum and migration policy

On Tuesday morning, MEPs will take stock of the results of the 13-14 December meeting of EU leaders, before debating the reform of the EU asylum and migration policy.

The main items on the agenda of the meeting of heads of state or government, on 13-14 December 2018 in Brussels, were the EU's long-term budget, external relations, migration and the single market. A separate meeting on 13 December, in EU27 format, was dedicated to Brexit.

Reforming EU asylum and migration policy

The stalemate in the reform of the common asylum system, particularly the lack of progress in updating the Dublin Regulation (which determines the country responsible for an asylum request) will also be the focus of a debate with the Council and the Commission.

Improving the management of migration flows into Europe, and the issue of responsibility-sharing among EU member states, will also be raised, in the context of the recent developments in the Mediterranean and the decision of some countries not to allow the disembarkation of rescued migrants and asylum-seekers.

Pesticides: a blueprint to improve EU approval procedure

Plans to boost trust in the EU approval procedure for pesticides, by making it more transparent and accountable, will be put to a vote on Wednesday.

Among many proposals, the report from the special committee on pesticides says that the public should be granted access to the studies used in the procedure to authorise a pesticide, including all the supporting data and information relating to the applications.

MEPs note that concerns have been raised about the right of applicants to choose a particular member state to report on the approval of an active substance to the European Food Safety Authority (EFSA), as this practice is seen as lacking in transparency and could entail a conflict of interest.

Member states jeopardising the rule of law to risk losing EU money

MEPs will debate and vote on rules to freeze EU payments to member states which interfere with courts or which do not tackle fraud and corruption.

If the EU Commission established that "generalised deficiencies as regards the rule of law" in an EU country threaten the management of EU funds, it could suggest measures ranging from reducing pre-financing to suspending EU budget payments. Parliament and EU ministers would have to approve any decision.

While broadly supporting the Commission's proposal, Budgets and Budgetary Control Committee MEPs added safeguards to make sure governments would still have to make payments to final beneficiaries, like researchers or civil society organisations, even if EU funding is suspended.

Promoting democracy, rule of law and fundamental rights

MEPs will also debate and vote on increasing funding for the Rights and Values Programme for the period 2021-2027 up to 1.834 billion euros, almost triple the amount proposed by the European Commission (€642 million). This funding would go towards promoting democracy, rule of law and fundamental rights across the European Union, including providing financial support to civil society organisations working on these issues.

Civil Liberties Committee MEPs added provisions so that EU countries involved in rule of law proceedings may lose the right to manage the funds allocated to them for this purpose themselves. They also want a fast-track procedure to disburse funds to support democratic dialogue in member states where the EU's founding values are at risk.

"InvestEU" programme: new boost for jobs, growth and investment

MEPs are set to approve a new EU programme to support investment and access to finance during 2021-2027. The aim is to trigger almost €700 billion in investments.

The "InvestEU" initiative should work like a launchpad for investments which otherwise would have been difficult. It follows and replaces the current EFSI (European Fund for Strategic Investments), set up after the financial crisis.

MEPs intend to improve the Commission's proposal by increasing the EU guarantee (from €38 billion to €40.8 billion, to trigger €698 billion in investments), by introducing new objectives like employment and climate protection and by strengthening the accountability of the programme's management.

Preferential tariffs to help Western Sahara to develop

A proposal to lower tariffs in the territory of Western Sahara to the same level as Moroccan tariffs will be put to the vote on Wednesday.

The Committee on International Trade gave the green light to extend the preferential tariff rates to the territory of Western Sahara after the European Commission and Morocco agreed on a traceability mechanism, which helps define the origin of products exported from the territory.

It backed the extension of preferential trade tariffs to allow the region to develop, even before there is a political solution to the status of Western Sahara.

The plenary will first vote on whether to seek the opinion of the European Court of Justice on the compatibility of the agreement with EU Treaties. If the answer is positive, the votes on Parliament's consent to the agreement and on the resolution will be adjourned to another plenary session. If the answer is negative, the votes go ahead.

Background

The European Commission liberalised trade with Morocco in 2013, but the decision ended up in court, as it covered the disputed territory of Western Sahara. The EU Court of Justice ruled in December 2016 that no trade agreement could cover Western Sahara unless the people of the territory had consented to it and unless the territory was explicitly mentioned in the text of the agreement.

Women's rights, rule of law, hate speech: MEPs assess fundamental rights in EU

MEPs will examine the situation of fundamental rights in the EU in 2017, pointing to women's rights violations, rule of law breaches and the rise of hate speech.

The draft text - to be debated on Wednesday afternoon and put to a vote immediately after - condemns gender violence and highlights the ongoing discrimination that women in Europe still face. It regrets that the EU institutions are not effective in protecting rule of law and European values.

MEPs are also concerned that freedom of speech and freedom of assembly are being increasingly restricted. They underline the need to combat hate speech, the rise of anti-Semitism and Islamophobia, as well as the persistent discrimination against and stigmatisation of LGBTI people in the EU.

MEPs want to invest more in future EU generations

MEPs will vote on Wednesday to increase the European Social Fund Plus (ESF+) and are set to make youth and children the main beneficiaries.

The Employment Committee proposes increasing ESF+ funding in the EU 2021-27 long-term budget by approximately 19% compared to the European Commission's proposal (from approximately € 89,6 billion to approximately € 106,8 billion in 2018 prices), of which €105,7 billion is to be managed jointly by the EU and member states.

MEPs want to see more resources devoted to youth employability and to ensure equal opportunities for children at risk of poverty or social exclusion.

It contributes to social inclusion, job opportunities, fighting poverty, education, skills and the employability of young people, as well as in better living conditions, health and fairer societies. The individual projects and programmes must contribute to improving economic, social and territorial cohesion.

European Fund for Transition to support workers made redundant

MEPs will vote on Wednesday on a revision of the European Globalisation Adjustment Fund supporting workers dismissed due to globalisation, technological or environmental changes.

The Employment committee wants the fund to also address the adverse effects of globalisation and technological transitions like digitisation, automation and the transition towards a resource-efficient economy.

In addition, MEPs are set to lower the threshold of eligibility, setting it at 200 lost jobs. They also want to change the name of the fund from European Globalisation Adjustment Fund to European Fund for Transition (EFT).

Challenges of multi-tier EU integration

Parliament is set to oppose 'Europe à la carte' and 'secondclass membership', in a resolution to be put to the vote on Thursday.

MEPs will take stock of the differing levels of European integration among member states, commonly referred to as 'Europe à la carte', 'variable geometry', 'multi-speed Europe' or 'first-and second-class membership'. They intend to set prerequisites, so that differentiation serves the European project, rather than endangering it.

They are likely to adopt recommendations for any future treaty change aimed to 'bring order' to the current process of differentiation and call for an end to the practice of permanent opt-outs from EU law.

MEPs raised the issue of the challenges of differentiated integration as part of a broader debate on the Future of Europe.

Background

Integrating into the EU can vary in pace, territorial scope and degree and may legally take various forms:

- enhanced cooperation among a group of countries (for example in divorce law)
- permanent structured cooperation (in security and defence)
- a few countries negotiated a permanent opt-out from EU legislation (for example Denmark opts out of the euro)
- transitional measures applied to new member states (Mechanism for Cooperation and Verification or temporary derogations).

How differentiation is perceived varies significantly depending on the national context. It may be positive, if seen as an opportunity to progress more rapidly in deepening integration, or negative, if seen as a path towards creating first- and second-class membership.
