

## The Week Ahead 06 – 12 March 2017

Committee and political group meetings, Brussels

**Reform of the EU asylum system.** Proposals to reform the Dublin system, which determines the member state responsible for processing an asylum application, will be presented and debated for the first time in the Civil Liberties Committee. The talks will include possible changes to ensure more solidarity and sharing of responsibility among EU countries in tackling the migration and asylum crisis. (*Thursday*)

On Tuesday at 11.00, lead MEP Cecilia Wikström will hold a press conference to outline her main proposals ahead of the committee debate.

**Taxation/EP inquiry.** The Special Committee on Money Laundering, Tax avoidance and Tax Evasion (PANA) will finalise its hearings on the roles of bankers, lawyers and accountants in the secret offshore financial vehicles. Journalists from the International Consortium of Investigative Journalists will also attend. *(Monday)* 

**Rule of law in Poland.** Civil Liberties MEPs will also debate the ongoing probe, launched by the Commission, into respect for the rule of law in Poland, with Commission First Vice-President Frans Timmermans. *(Thursday)* 

**International Women's Day.** MEPs and national MPs will gather for a meeting on women's economic empowerment. Parliament's President Antonio Tajani, Gender Equality Commissioner Vera Jourová, Alia El-Yassir, UN Women Deputy Director for Europe and Central Asia and activist Vandana Shiva, among several other guests, will join this event organised by the Women's Rights Committee. *(Wednesday and Thursday)* 

A seminar for journalists on "Women's Economic Empowerment", with leading MEPs and key media players, will look at gender equality in political and economic decision-making, the pension gap and the challenges and obstacles to achieving a work-life balance. French physicist Hélène Langevin-Joliot and British True and Fair Foundation founder Gina Miller are among the guest speakers. *(Tuesday and Wednesday)* 

**Plenary preparations.** Political groups will prepare for debates and final votes on firearms and on blood minerals, and discuss various aspects of the circular economy and waste, prior to votes on four legislative proposals. They will also prepare votes on resolutions to overcome obstacles to EU citizens' right to free movement, EU external actions to address the refugee and migrant crisis, and the fundamental rights implications of big data. Lastly, they will prepare votes on new rules for money market funds and long-term shareholders' engagement as well as on corporate governance.
