1. INTRODUCTION

From January 2003, the former five Programmes established under Title VI (Grotius Criminal, Oisin, Stop, Falcone and Hippokrates) were replaced and brought together into a single Programme - the AGIS Framework Programme.

The AGIS Programme, a framework programme that aims to promote police and judicial cooperation in criminal matters, was adopted on 22 July 2002 by a Council Decision¹ (hereinafter called AGIS Decision) and it covers not only the same type of activities, but also the same topics included in the former five Programmes.

There is, in fact, a great continuity in the action carried out by Grotius, Oisin, Stop, Falcone and Hippokrate Programmes and the AGIS Programme. This latter has also incorporated the activities previously funded under budget heading B5-831 (drugs).

The AGIS Programme runs from 2003 to 2007 and it has a total budget of 77 millions euros, increased from the original 65 million euros following the accession of the ten new Member States in May 2004. Given that the new financial perspectives will apply in 2007, the Commission has proposed that the AGIS programme be replaced from 2007 by the new Framework Programme on Security and Safeguarding Liberties.

This document constitutes the first annual report on the implementation of the programme prepared by the Commission in accordance with Article 11 of the AGIS Decision and it provides a narrative description and some statistical tables of the actions funded under the 2003 budget. This report does not replace the midterm evaluation exercise foreseen in Article 11, evaluation by an external contractor.

2. THE IMPLEMENTATION OF THE 2003 BUDGET

The Commission adopted the 2003 Annual work programme and published the Call for proposals in January 2003^2 . The total budget available for 2003 was €11.780.000, of which €11.000.000 was for projects and €780.000 for operating grants.

2.1. Projects

The Commission received a total of 216 proposals within the deadline of 7 March 2003, approximately 7% more than the number of applications received in 2002 under the previous programmes (Grotius, Oisin, Stop, Hippocrates and Falcone), taken together.

The proposals were evaluated by the Commission services. This work started with the analysis of formal eligibility criteria (use of budgetary and grant application forms, starting date of the project, indication of the partnership): 10 proposals did not meet these conditions and were considered ineligible.

The eligible proposals were subsequently evaluated on their contents by the Commission services, according to the selection and award criteria laid down in the AGIS Decision, as well as those mentioned in the Annual Work Programme - 112 projects were found of sufficient quality and clarity to be recommended for co-financing.

After having received a positive opinion of the AGIS Committee at its meeting on 28 May 2003, the Commission adopted the list of 112 selected projects on 10 June 2003.

A description of the selected projects is annexed to this report (Annex I). In this list, the amounts shown for the total estimated cost and co-financing for each project correspond to the amount included in the budget of each project after the analysis and revision accomplished by the Commission. These "revised" amounts only exist for the 112 selected projects. In the case of the non selected or non eligible projects, there was no revision of the budget proposed by the applicant.

2.1.1. Non Budgetary Indicators

As referred to above, the AGIS Programme replaced the five former Title VI Programmes and it therefore inherited all the different fields of intervention and target-groups that existed in those programmes. An overview of the distribution according to different aspects of the projects received and of those co-financed is presented in the following sections.

a) Distribution of the number of projects per Member State

Out of the total number of 216 proposals received, 57.8 % were presented by three Member States (DE, IT, and UK). Among the co-financed projects, the share of these Member States is almost the same (58%). The second most numerous group of applications comes from Belgium, Spain, France, Ireland and the Netherlands, with 31.8% of the total of projects received and 30.3% of the projects co-financed. France, alone among the bigger countries, does not have a percentage of the total number of projects received or co-financed comparable to its weight in terms of population.

National Authorities present the highest percentage of projects -45.8% of those received and 60.7% of those co-financed. The second most important group includes Universities and NGO's with 17.9%, followed by Regional and Local Authorities with 9.8%.

As mentioned previously, the AGIS Programme covers all the fields of intervention that were formerly in the Grotius, Oisin, Stop, Falcone and Hippokrates. In this context, most projects previously funded by Grotius (penal) are now included in "cooperation between judicial authorities". The former Oisin Programme is now reflected in the projects of "cooperation between law enforcement authorities". Falcone and Hippokrates were replaced by "prevention and fight of criminal groups and prevention pf specific forms of crime". On the other hand, the projects now under "Victim assistance" cover a larger group than those previously funded under Stop. "Support of activities" refers to operating grants, meaning those grants that aim to support the activities of an organization and not a project.

The two most important fields of intervention are: a) the cooperation between law enforcement authorities (36.1% of the number of projects received and 48.2% of those co-financed) and b) crime prevention together with the fight of specific forms of crime (43.5% and 37.5%, respectively).

Conferences and seminars are by far the most important type of action and they account for almost half (46.4%) of the total number of projects co-financed. With 26.8%, the second most relevant group concerns research, studies and the establishment of networks. Training and exchange programmes, which are by nature more difficult to implement than the above mentioned actions, contribute to a fifth (20.5%) of the number of projects co-financed.

In financial terms, there are (as was the case for the number of projects) three Member States (DE, IT and UK), who received the largest share of the subventions awarded (54.9 %). Belgium occupies a rather isolated position with 11.1%, followed by a third group to which belong Ireland, the Netherlands, Spain and France, with 24%. France has a rather modest share of 4.7%. In the case of Italy, it is interesting to note the great difference between the

total amount requested and the grants actually received. Italy remains, nevertheless, the largest beneficiary of the AGIS Programme, with a relatively small average grant request (27 projects for 1.8 millions euros, or 67 000 euros/project; this compares with 124 000 euros/project in the case of the UK).

The pattern seen before in the analysis of the number of projects presented is almost identical in the analysis in financial terms. The National Authorities have the highest share of the total grants awarded, above half of the total, closely followed by the universities and NGO's (24.5%).

The pattern here is almost the same as previously analysed under Point 2.1.1.c): cooperation between law enforcement authorities and the prevention of crime have by far the largest share of the grants awarded.

Although the ranking in terms of financial importance remains the same as the ranking in terms of the number of projects, there are however some differences worth underlining: a) the conferences and seminars that accounted for 46.4 % of total projects received a somewhat smaller share (37.8%) in financial terms; b) the share of research, studies, creating networks passes from 26.5% (number-wise) to 34.1% in terms of the grants awarded. This reflects clearly the difference of the cost of projects in these latter fields.

3. CONCLUSIONS

As 2003 was the first year of implementation of the AGIS Programme, it can be considered as an experimental year in the sense that certain procedures were subsequently improved and subject to clarification, notably within the AGIS Committee.

The high number of proposals received shows clearly the interest that the programme has among its potential beneficiaries – Ministries of Justice and Home Affairs, Police forces, Customs departments, Universities, ONG's and private companies. The demand is indeed much greater than the budget available – for 2003 the total budget amounted to 11 780 000 euros and the total grants requested were 31 610 058.00 euros, which is 2.7 times greater. Once the selection and evaluation were done, and the budgets of the projects proposed for co-financed analysed and revised to be fully in line with the financial rules, the total of the grants awarded amounted to 9 299 798.26 euros, in other words almost 2.5 millions euros below the available appropriations.

Nevertheless, a high proportion of the applications received presented administrative and/or substantive failings by comparison with the requirements set out in the call. The decision was

then taken, in the interests of equality amongst all candidates and recognising that this first year of the programme was a 'learning period' for candidates, to examine all proposals which presented similar failings.

At the AGIS committee meeting of 28 May 2003, the Commission announced that:

"Exceptionally for the first exercise and having regard to some difficulties encountered by the applicants in the use of the application forms in some languages, the evaluation was also made for projects not filling the totality of formal criteria. Applicants will have to make the necessary corrections before the adoption of the financial convention. All applicants that had initial difficulties in providing the requested documents and using the Excel template provided for the budget form were asked to send the missing documentation within a short period of time; the objective being to ensure that all applicants were able, before the end of the evaluation procedure, to fulfil all requirements."

Despite the difficulties encountered, the AGIS Programme fulfilled its role in 2003 of providing financial resources to meet the Member States' needs in terms of the full implementation of the legal instruments proposed and adopted by the EU (European Arrest Warrant, legislation against the terrorism, victim's assistance, trafficking of human beings, etc.), as well as the instrument that enhances and encourages transnational actions of national organizations in a European perspective.
