The chair announced that the co-rapporteurs would be mainly focusing the discussions on the CSF.

Mr Van Nistelrooij outlined that the procedure was now clear. The CSF will be an annexe of the CPR - which is already available to the Members. The rapporteur also stressed that probably more time would be needed to analyse and understand the procedure, with the new CSF. Mainly, he stressed on the importance to have further legal clarifications on the content.

The rapporteur stressed that a performance reserve was highly undesirable. Better procedures and programming could be developed.

Most importantly, Ms Krehl added that the chapter 4 of the CSF was suppressed as, according to her opinion, we were not in need of these provisions.

Both co-rapporteurs stressed that MEPs should avoid to table amendments referring to the Financial Regulation as this one was not already adopted. Many things have to be clarified regarding the relations with this text.

However, the Chair has informed the committee that for the annexe on CSF the deadline will be June, 7th at noon. The amendments will be introduced via a special procedure and not via the AT4AM.
