2. Adoption of agenda

The agenda was adopted.

3. Chair's announcements

The Chair officially welcomed the Scottish Parliament Petitions Committee members and secretariat.

4. Other business

There was no other business.

5. Delegation of the Scottish Petitions Committee The Chairman announced the following:

Mr David Stewart, MSP Convener head of the Scottish Parliament's Petitions Committee welcomed the opportunity to visit in the European parliament and its

Petition Committee. He invited the PETI Committee to pay a visit to Edinburgh. He introduced the work of his Committee: The Committee was established in 1999 and is one of the permanent Committees. In 2004 an e-petition system was created, which has made easier for citizens to submit their petitions. As a matter of fact the Scottish Parliament was the first in the world, which organised the system. It is vital to develop the online system. Openness and accessibility are e.g. key words as well as guiding the citizens through the petition process. Mr Stewart emphasized that each petition is threatened on its merits no matter how many signatures it has. He wants to see that in each 28 members states the same petition system would be possible that in Scotland or in the EU-parliament.

A video presentation was given on the Scottish Petition Committee.

Recognition of qualifications

6. **Petition 689/1998 by David Petrie (British), on behalf of the 'Associazione Lettori di Lingua Straniera in Italia', on the situation of foreign-language lecturers in Italy (in the presence of the petitioner)**
and
508 and 509/2007 by Simon Lander and Cheryl Wolley (British), on discriminatory treatment of foreign-language assistants at Cagliari university and other Italian universities
and
petition 1152/2011 by M.A (Spanish), on discrimination against foreign language assistants in Italian universities

Mr David Petrie went through in details the history of this petition, which deals with the working conditions of the foreign language teachers and assistants in Italy. Bottom line is discrimination based on their nationalities. The case has been in front of the European Court several times and Italy has each time failed to follow the Court's ruling. Also Italy has changed its law in this matter.

Mr Perez-Flores on behalf of the Commission said that the EC does not agree with the interpretation of the petitioner's on the EC Court ruling. The Court's judgement does express that the Italian law complies with the EU law. The EC came to the conclusion that there is no infringement under article 45 TFEU. With reference to other articles and the Gelmini law, the EC has found it necessary to obtain from the Italian authorities specific information about possible effects of the application that would affect in the proceedings. Once this information is received from the Italian authorities, the EC will analyse the matter and will inform the Committee of the outcome of its assessment.

Decision: The Committee decided to keep the petition open, write to the Italian authorities. The Committee is expecting the EC information and assessment of these petition in due time.

Social Affairs

7. **Petition 1169/2013 by Arianna Formato (Italian), bearing 135 signatures, on job insecurity in Italian schools**

Mr Timm Rentrop on behalf of the Commission stated that the petition relates to two different subjects, one is relating to certain teaching qualifications in Italy and the other one to fix-term nature of employment questions. He explained that on the first question concerning diploma recognition versus qualifications as a teacher is purely national matter and should be dealt according Italy law thus diploma recognition directive does not apply in these cases. On the other part concerning fixed-term employments there are infringements process ongoing in the EC, he added that just recently there is a ruling of European the Court on this specific issue and discussions with the Italian authorities are scheduled very soon about the heavy use of fixed-time employments in Italian schools. There are several petitions on this issue, which could be grouped in one document and discussed all at the same time.

Speakers: Mr Walesa, Ms Evi and the Chair.

Decision: The Committee decided to keep the petition open. The Committee will come back to the petition as soon as the EC provides more information after its discussions with the Italian authorities.

8. **Petition 1961/2013 by Edward Marnell (British), on behalf of sir Cammel Laird strikers, on Unjust treatment of Cammel Laird strikers**
(in the presence of the petitioner)

Mr Marnell, on behalf of Cammell Laird strikers, who was personally involved in the strike, which took place in 1984, explained the background of the strike and events in the context, which violated workers human rights and were unjustified. Workers were dismissed, jailed for many days and their pension rights were rescinded. Since those days the workers have been looking for justice including the request of access to the documents of this event. Lack of documentation has prevented the strikers to take the case in front of the court.

Ms Sasha Garben, on behalf of the EC, regretted deeply the hardship what the petitioner and his colleagues have been suffered. She said the EC is currently finalising the situation. She also explained that the EU has not a general human rights competence. The EC is now assessing whether the UK was acting in the scope of EU law in this matter.

Decision: The Committee decided to keep the petition open, to wait for the final assessment of the EC and to send a letter to the UK authorities asking a formal apology due to unjustified actions taken at that time towards the workers.

Fact-Finding Visit Proposals

9. Poland Via Carpathia

Petition 0053/2013 by Rafal Dąbrowski (Polish), bearing 31 signatures, on the construction of the ‘Via Carpathia’ road (Poland - Lithuania - Slovakia)

Mr Poreba (MEP) introduced the petition on behalf of the petitioner. He declared the support for the construction of the ‘Via Carpathia’ road in the Republic of Poland, from its border with Lithuania to its border with Slovakia. The road would develop these regions in Poland and neighbouring countries. He also mentioned that the road would improve the security of EU and wanted to keep the petition open.

Mr Siwinski on behalf of the EC said the importance of the road is recognised and it is a part of the TEN-T network. Also he mentioned that this project can be co-financed within the cohesion funds at national level.

Decision: The Committee decided to close the petition by the votes 10 in favour, 10 against and 3 abstentions.

10. Cyprus - Famagusta

Petition 0733/2004 by Loizos Afxentiou (Cypriot), on behalf of the Famagusta Refugee Movement, concerning the return of the closed area of the occupied town of Famagusta to the original inhabitants

The Chairman drew attention to the written statement sent by the petitioner regarding the situation in Cyprus and mainland Varosha. Ms Di Bucci on behalf of the EC said that the EC has given its written reply to the Committee in 2010 and then she explained the latest developments in this complex issue. Two leaders of the two communities in Cyprus, Mr Christofias and Mr Talat, have formally in recent years negotiated tens of times on the Cyprus problem without any tangible results. The EC is supporting these talks as well as the United Nations secretary-general in order to facilitate the negotiations. The return of Famagusta area to its lawful owners is no doubt one of the key elements of the talks and to achieve a comprehensive solution.

Now, the EC has urged the community leaders to return back to the negotiation table.

Speakers: Ms Sakorafa, Mr Hadjigeorgiou, Mr Kyrkos, Mr Walesa and the Chair.

Decision: The Committee decided to keep the petition open, to send a letter to the Turkish government referring to the written declaration of the EP, the UN resolutions and to the report of the previous fact-finding visit along with its conclusions. Also it was decided to write to the EC asking its reactions to the resolution on this issue adopted by the Parliament two years ago. This would be the first step in a series of actions in order to make some progress in the matter.

11. Presentation by the European Parliamentary Research Service (EPRS)

Mr Dunne, acting director of the Impact Assessment and European Added Value Unit, explained the background of recently established new Directorate General. DG EPRS is providing briefing papers and research and analysis to members and committees. Mr Dunne also said that they would like very much to cooperate with PETI Committee due to its special role as a committee with direct contact to European citizens.

13. Chairman's announcements concerning the Coordinators' decisions

1) Draft agendas:

The January draft agenda will be circulated for discussion among the coordinators. They are asked to approve it.

The coordinators extraordinary meeting will be organised on 9.12.2014. The main item on the agenda will be the "Balayage" procedure, first phase. A list of recommendations will be forwarded containing proposals made by the secretariat. A preparatory meeting will take place inviting the secretariat and representatives of the political groups.

2) Appointment of drafts person for opinion

Opinion on the Annual Report on the situation of fundamental rights in the European Union. COM (2014) 0224.

Decision: The Rapporteur will be nominated by the S&D Group.

3) Arrangements for List 3 (possibly inadmissible petitions)

Decision: The List 3 provided by DG PRES is to be circulated to all committee

members, for their comments or to the approval.

4) Requests for the modification of recommendations

Petition 2589/2013 by Richard Niney (French) on the rights of embryo - at the request of the ECR Group

Decision: the Coordinators decided by clear majority to follow the original recommendations.

Petition 2596/2013 by Luis Miguel Garcia Zurro (ES) on an announced reform of the Spanish criminal code (Annex)

Decision: the Coordinators decided to follow the original recommendations.

5) Request for studies

The list of possible studies was delivered and presented by the Policy Department C to the coordinators.

Decision: The draft list of studies was adopted. The proposed studies are:

- The Right to Petition

The study would be related to the hearing that the PETI committee decided to hold in June/July 2015, where the study could be presented. It should examine the citizens' right to petition and its functioning in the EU, in its Member States and eventually in relevant third States, highlight similarities and differences, with the aim of identifying good practices and enhancing cooperation within the EU to enhance the effectiveness of the right to petition and citizens' rights.

- The European Citizens' Initiative

As a follow up to the recent study on the ECI, the research will examine the proposals related to the Commission evaluation and review of the European Citizens' Initiative, in connection with a hearing in the spring on the matter and a possible parliamentary report on the ECI during 2015.

- River basins and flood management

On the basis of the petitions received by the EP and the repeated floods taking place in the EU, the study should look into the implementation of EU law and notably of directive 2007/60/EC on the assessment and management of flood risks and 2000/60/EC on water policy to identify possible shortcomings and provide recommendations for improvement in the prevention, protection and preparedness, assessment and management (including of the consequences) of floods' risks and floods.

- Animal welfare

Petitions on animal welfare are constant subjects of citizens' petitions, showing growing concern and interest in the matter. A study could examine the implementation of EU directives on animals (on pigs, calves, laying hens, birds, etc), as well as look into the potential of Article 13 TFEU to take further EU initiatives in the field (such as

on stray dogs, pets, etc), notably in the view of the elaboration of a Framework Law on Animal Welfare, as requested by the EP and currently being examined by the Commission.

- Citizens' right to free movement

The right to free movement is one of the main fundamental rights attributed by the Treaty to EU citizens, as further regulated by Directive 2004/38/EC. Notwithstanding its importance, a series of obstacles have impeded the full and correct implementation of the directive at national level, as demonstrated by the number of petitions received on the matter, the number of cases brought to courts and the requests for review raised by some Member States including recently. The study could examine the petitions on the matter, the jurisprudence, the discussions underway and the level of implementation in order to ascertain how to better implement the directive and protect the right to free movement of EU citizens and their families and fight against possible abuses. It could eventually be defined and carried out together with LIBE.

- Children's rights

The PETI committee has received in time a high number of petitions raising concerns in relation to children's rights and has recently decided to fast-track petitions on the matter. A number of problematic issues arise in relation to bi-national couples and alleged discrimination on the basis of nationality in matters of parental responsibility, visitation rights, adoption, abductions, differences in the ECJ and ECHR jurisprudence, etc. The committee intends to follow up the issue in 2015, including in relation to the Commission guidelines in preparation and the upcoming revision of the Brussels II Regulation on jurisdiction, recognition and enforcement of judgments in matrimonial matters and matters of parental responsibility, through an appropriate study on the matter and taking into consideration the already available studies on the matter.

6) Any other business. Items for information

Decision: The Coordinators took note of the following:

- a) Parliamentary Project Portfolio within the Strategy Execution Framework of the European Parliament (Secretary General, October 2014) and
- b) Hearing organised by the INTA Committee on TTIP - "What's in for the European Citizens?" (Dates: March/April 2015).

14. Report on the Annual Report on the activities of the European Ombudsman in 2013

Decision: The Draft Report of Mr Jaroslaw Walesa was adopted by votes 23 in favour, 0 against and 3 abstentions.

Environment

15. Presentation of the "In Depth Analysis on the Routine tail docking of pigs" prepared by the Policy Department based on Petition 0336/2012 by C.R. (Danish), on behalf of Dyrenes Beskyttelse (Danish Animal Welfare Society), concerning the routine tail-docking of piglets in Denmark

Mr Ottavio Marzocchi from the Policy Department of the Citizens Rights and Constitutional Rights gave a presentation a Study requested by the Committee on routine tail docking of pigs. According to the study there is a violation of the Council Directive 2008/120/EC, which lays down minimum standards of protecting pigs and tail cutting. Especially he mentioned Denmark and UK as an example of such countries, which do not comply the directive. A tail biting is an abnormal behaviour of pigs in the circumstances where pigs are bored and stressed. As a solution for this biting is tail docking, this however shouldn't be any routine and is causing problems for pigs' health as well.

The EC has worked in guidelines and e-learning tools for members states and farmers trying by those means increase better implementation of the directive. As a conclusion he said that the EC should use also enforcement policy after 20 years of violation of the directive and probably also take actions legal against some member states.

Video presentation by the petitioner. Birgitte Damm

Mr Simonin, on behalf of the EC explained that tail docking is a broad question and it is not easy to resolve and it is also a technical issue to set up alternatives concerning breeding environments. The EC is working to find feasible solution and currently wants to progress through negotiations. The EC does not consider infringement procedures to be the most effective instrument and does not propose to amend existing animal welfare legislation.

Speakers: Ms Auken, Mr Hazekamp, Ms Mizzi, Mr Jahr, Ms Karlsson, Ms Evi, Ms Auken and the Chair.

Decision: The Committee decided to keep the petition open, to send a letter to the EC requesting detailed comments on the Study and explanation why the EC has not started infringement procedure. Also it was decided to send the Study to ENVI and AGRI for a follow-up as well as a letter to the Legal Service of the EP asking its opinion of the EC's failure to act in this violation of the directive.

16. Petition 0615/2013 by Maurizio Benedetto (Italian) and 25 co-signatories concerning waste management in Calabria (Italy)

The petitioner introduced his petition, which concerns inefficient waste management and disposal in the region of Calabria. Things are not done by principles of environment protection and the situation is getting worse in the whole southern Italy. The directive 2008/198/EC is violated. He proposed a special task force to be created to observe the situation in find solutions in Calabria for proper waste management and people's health.

Ms Ferrara, one of the promoters of the petition, described the reasons for the unbearable situation. She said many actions are needed like increasing awareness of citizens, regional cooperation and planning, private and public funding. She also was calling for a task force to tackle different problems.

Mr Manganaro, on behalf of the EC told about the European Court ruling at that day concerning infringement procedure against Italy's illegal dumping and as a result Italy has to pay 40 m€ fine. There is also another 42 m€ fine to be paid by Italy.

He said the EC has worked in this issue a long time and Calabria is not the only region with similar environmental problems. The EC has asked all member states to update the implementation of their management plans of waste. When the information is gathered the EC will assess the plans. Also regional citizens should be consulted.

Speakers: Ms Auken, Mr Jahr, Ms Evi and the Chair.

Decision: The Committee decided to keep the petition open, ask the EC to assess influence of the the Court ruling especially in this petition case and other waste management issues and send a letter to Calabrian authorities. It was decided also that all waste management petitions could be grouped together in the future as a common agenda item. The Committee will consider whether it will appoint a rapporteur for all waste management issues at that point in 2015.

Fact-Finding Proposal

17. Spain - Ebro River basin

Petition 0938-2012 by Matilde Font Ten (Spain), on behalf of Coordinadora Antitransvasaments, on the Proposed Draft Hydrological Plan for the Ebro river basin, which would infringe a number of environmental directives
(in the presence of the petitioner)

Ms Abella Cordoniú, a petitioner thanked that they have been invited again in front of the PETI Committee. She said the plan of the Spanish government is false and is based on wrong considerations. The petitioner said that the hydrological plan violates several important directives, especially the Water Framework Directive, the Habitats Directive and Directive on environmental liability. Also the hearings were not properly organised. Government's money spending has to be stopped.

Ms Alvarellós, speaking on behalf of the EC informed that the EC has had a bilateral meeting with the Spanish authorities where the content of the plan was discussed. She said some lack of control system was noted, to say no follow-up systems was putting forward, ecological quality was not sufficient, and no proper targets set, which are important in a protected area. Also a high level of infrastructure plans without proper justifications worried the EC. The Commission is now assessing the whole plan and would like to publish it before the Water Conference to be held in March 2015. She said of course the EC hopes that the Spanish authorities will make sound improvements to the plan and fulfils the requirements of the Water framework directive.

Decision: The Committee decided to keep the petition open, and follow closely the case and wait for the final assessment of the EC after its further dialogue with the Spanish authorities.

Environment

18. Petition 1957/2013 by Mariano Velasco Lizcano (Spanish), on behalf of Asociación Ecologista para la Defensa del Acuífero 23 (AEDA 23), on the management of the hydrological plan of the Alto Guadiana (Spain)

Ms Alvarellós, on behalf of the EC did not want to go to the details of evaluation process of the EC, she said precaution principle is always good in water management questions. The EC will publish a report of the issue in the beginning of the next year (2015).

Speakers: Cabezón Ruiz, Ms Albiol Guzmán, Ms Estaras Ferragut and the Chair.

Decision: The petition was decided to keep open and to wait for the assessment of the EC.

The Chair, Ms Wikström, closed the meeting at 12.30. She reminded the members of the Ombudsman's Hearing at 15.00.
