### FINAL DECISIONS

#### 1. Adoption of the draft agenda

##### 2.1 New rules on Committee missions

#### **DECISIONS:**

Coordinators decided on the following missions "inside Europe":

1. Serbia - 18-19 June (number of MEPs tbc, from DROI quota)
2. Turkey - 24-25 September (number of MEPs tbc, from DROI quota)

### 2.4.2 Outside Europe

#### **DECISIONS:**

*Please note that all DROI proposals will first have to be approved by the AFET EB before requests for authorisations can be made.*

Coordinators decided on the following missions "outside Europe":

1. Ukraine - week 30, 20-24 July (max. 6 MEPs + Chair hors quota)
2. Morocco - week 45, 3-6 November 2015 (max. 6 MEPs + Chair hors quota)

Please note that the above missions will take place in parallel with the missions already agreed by the DROI Enlarged Bureau to Israel/Palestine (week 30) and UN GA in New York (week 45).

NB. The above missions were endorsed by the AFET Enlarged Bureau of 31 March 2015

### 3. Hearings for second half of 2015

#### **DECISIONS:**

Coordinators decided on the following hearings:

- 1) Assessing GSP+ as a tool for human rights promotion and how to monitor its implementation (*joint hearing with INTA*)

- 2) Use of drones and human rights standards – follow up to DROI study/2014 hearing on drones (*joint hearing with SEDE*)
- 3) Hearing on forced marriages following on from the study on this topic, jointly with LIBE and FEMM
- 4) Joint FEMM/SEDE hearing on the 1325 UN Landmark resolution on Women, Peace and Security (TW) - *possibly in September*
- 5) Sport (large sporting events) and human rights - May 2015
- 6) Death penalty - close to International Day against the Death Penalty (12/10) - 1 October 2015
- 7) 3rd "Eastern Partnership Ombudsman Summit" - September 2015
- 8) Land grabbing at a later date - to be arranged at a later date, to be agreed by the Enlarged Bureau

NB. AFET Enlarged Bureau on 31 March endorsed only the following 3 hearing topics:

- Sport (large sporting events) and human rights - May 2015
- Death penalty - close to International Day against the Death Penalty (12/10) - 1 October 2015
- 3rd "Eastern Partnership Ombudsman Summit" - September 2015

The remaining hearing topics will be requested jointly with the other competent committees by letter for ad hoc authorization.

#### 4. **DROI Work Programme**

New items proposed for approval:

**DECISIONS:** The Coordinators adopted the items below for the Work Programme:

- Exchange of views with Denis Mukwege, Sakharov Laurate 2014 - on 26 March.
- Presentation of the 7th annual report on the death penalty in Iran by *Ensemble contre la Peine de Mort* (in association with the Delegation for the relations with Iran), as part of a broader assessment of the overall HR situation in Iran - date to be confirmed based on the availability of speakers.
- Human rights situation in Venezuela - including with the NGO VenEuropa and other civil society representatives (April or later)

- Policy exchange with members of the Asian Inter-Governmental Commission on Human Rights (AICHR), in follow-up to the 20th EU-ASEAN Ministerial meeting - autumn 2015, exact date tbc
- Coordinators decided to revisit the issue of Eritrea at a later date

## 5. Human rights activities for 2015

(in the framework of the 2015 programme of human rights actions, to be endorsed by the Democracy Support and Election Coordination Group (DEG))

### **DECISIONS:**

Coordinators endorsed the proposal for a hearing/conference on "*Respecting human rights in the context of migration flows in the Mediterranean Sea*" in September/October 2015, in the framework of the 2015 programme of human rights actions, to be endorsed by the Democracy Support and Election Coordination Group (DEG)

## 6. Follow-up to the EP urgency resolutions by the EEAS

### **DECISIONS:**

Coordinators decided

1) to continue organising follow-up sessions with the EEAS on EP urgency resolutions **in camera**

2) the next resolutions selected for follow-up are:

- Burundi, in particular the case of Pierre Claver Mbonimpa (September 2014)
- Persecution of Human Rights Defenders in Azerbaijan (September 2014)
- Nigeria, recent attacks by Boko Haram - (July 2014)

Coordinators also decided to draft a letter to the EEAS asking for written feedback and information on urgency resolutions adopted by plenary and to schedule follow-up sessions once sufficient time (5-6 months) has passed since the adoption.

## 7. Appointment of an MEP responsible for mainstreaming children's rights

### **DECISIONS:**

Coordinators decided to appoint Kinga GÁL (EPP) as the member responsible for the mainstreaming of children's rights in the work of the Subcommittee.

8. **Any other business**

Members were reminded that requests for studies can be made on an on-going basis, but have to be agreed by the DROI Enlarged Bureau and then approved by the AFET Enlarged Bureau. It is recommended that studies be linked to pillars and hearing topics already agreed by DROI.
