SHORT JUSTIFICATION

The proposed Directive supports Member States to achieve their national commitments as well as their obligations regarding accessibility under the United Nations Convention on the Rights of Persons with Disabilities (UNCRPD), to which the EU is a party, together with 25 of its Member States.

In the Transport sector, the Directive focuses on non-discrimination and the provision of assistance for persons with reduced mobility when using transport especially on the Passenger Rights Regulations for all modes of transport.

As there is EU legislation concerning the accessibility of passenger transport vehicles and technical standards to ensure it for some transport modes, the Directive will not affect their scope of application.

Definitions

Rapporteur extends the definition of “persons with functional limitations” to “persons with reduced mobility” as requested by NGO.

Scope

Some amendments propose to extend the scope of the Directive. Modes of transport should also extend to urban transport. Otherwise intermodality should not be effective. Free mobility is not possible without accessibility arriving at urban centres.

The built environment must also be adapted to really get accessibility to the main transport systems. Rapporteur proposes the Directive to obligate Member States to do so.

Tourism services are also mentioned as a main objective for the Directive’s scope.

European rail legislation is the transport sector best adapted to the new accessibility criteria, but the purpose of this Opinion is to extend these national regulations to the rest of the transport sectors, including in some cases the private sector.

Cut-off date

The cut-off of six years for entry into force of this Directive should be reduced to four, except for adaptation of the built environment and vehicles (remaining at six years).

AMENDMENTS
