- Heard the Chair inform the meeting that a high-level conference on migration management would take place in the European Parliament on 21 June 2017 and noted the request from the Chair of DROI to associate the Sub-committee in this event.
- B. Merger of AFET Studies on Ukraine which were decided in the EB of 21 March 2017
- Decided to merge two previously agreed requests for studies into one request for a study on Ukraine, Georgia and Moldova.
- C. Report on the annual Report from the Council to the European Parliament on the Common Foreign and Security Policy
- Noted that the annual CFSP report would be allocated to the Chair.
- D. Hearing titled: “Hearing on R2P: Global Political Commitment on the Responsibility to Protect” scheduled for 20 June 2017
- Took note of the format and speakers of the hearing.
- E. Attendance of Members in Workshops and Hearings
- Heard the Chair refer to the low attendance at some recent AFET hearings and workshops and decided to consider this when deciding on such events in the coming months.

- Heard the Chair note the possibility of AFET organising an extraordinary meeting with Mr Evo Morales, President of Bolivia, on 8 June 2017.

- Decided to invite the EEAS for an exchange of views in Committee on the situation in the Maldives, possibly to be followed by a plenary resolution.
- C. Adoption of a recommendation to the Council on the Eastern Partnership Summit of November 2017
- Decided to draw a recommendation under Rule 113 of the Rules of Procedure and invited the political groups to suggest a rapporteur; the final decision will be confirmed by written procedure.
- D. Organisation of an exchange of views with newly appointed Heads of EU Delegations
- Decided to organise exchanges of views in committee with the appointed Heads of EU Delegations in Israel, Morocco, Nigeria, Russia, Serbia, Syria and Venezuela.

Invited the political groups to put forward a proposal for a package decision on monitoring rapporteurs, to be endorsed at the next meeting of the Enlarged Bureau.
