At the sitting of 5 May 1999 Parliament adopted its position at first reading on the proposal for a European Parliament and Council regulation on measures to promote the conservation and sustainable management of tropical forests and other forests in developing countries (COM(1999)0041 - 1999/0015(COD)).

At the sitting of 20 January 2000 the President of Parliament announced that the common position had been received and referred to the Committee on Development and Cooperation (12487/1/1999 -C5-0014/2000).

The committee had appointed Fernando Fernández Martín rapporteur at its meeting of 27 July 1999..


It considered the common position and the draft recommendation for second reading at its meeting of 27 January 2000.

At its meeting of 22 February 2000 it adopted the draft legislative resolution unanimously.

European Parliament legislative resolution on the Council common position for adopting a European Parliament and Council regulation on measures to promote the conservation and sustainable management of tropical forests and other forests in developing countries (12487/1/1999- C5-0014/2000 – 1999/0015(COD))

This amendment was proposed at first reading. It stresses the need for a global and consistent approach.

Justification:

This amendment was adopted at first reading. Requiring bank guarantees could exclude a fair number of NGOs from participating in the implementation of the regulation.

(Amendment 9) Article 8

The financial framework for implementing this Regulation during the period from 2000 to 2006 shall be EUR 63 million.

The annual appropriations shall be authorised by the budgetary authority within the limits of the financial perspective. The financial framework for implementing this Regulation during the period from 2000 to 2006 shall be EUR 249 million.

The annual appropriations shall be authorised by the budgetary authority within the limits of the financial perspective.

Justification:

The amount provided for by the Council is based on the Council's draft budget for 2000 (EUR 9 million in reserve for budget line B7-6201). In setting the financial framework for this regulation the Council has simply taken the sum of 9 million and multiplied it by seven for the seven year period of this regulation. During the second reading in the budget procedure Parliament increased the amount for 2000 to EUR 30 million, taking into account the extremely difficult budgetary situation predicted in category IV (Kosovo, East Timor, etc.). It should be borne in mind that the amount for budget line B7-6201 was set at EUR 45 million in 1999. A sum of 249 million for seven years takes account of the difficult budgetary situation in 2000 and also guarantees a 'critical mass', which is required for the projects in this area.

(Amendment 10) Article 9 (2)

Each year, the Commission shall adopt, in accordance with the procedure laid down in Article 10(2), strategic guidelines and priorities for implementing the activities to be carried out in the following year.

Justification:

This amendment seeks to increase the transparency of the implementation of the regulation.

(Amendment 11) Article 10 (2)

2. Where reference is made to this paragraph, Articles 4 and 7 of Decision 1999/468/EC shall apply, having regard to the provisions of Article 8 thereof.

2. The measures to be taken for the implementation of this Regulation concerning strategic guidelines and priorities shall be adopted by use of the management procedure referred to in Article 4 of Council Decision 1999/468/EC, having regard to Article 7 thereof and without prejudice to Article 8 thereof.

The measures to be taken for the implementation of this regulation concerning all other matters shall be adopted by use of the advisory procedure referred to in Article 3 of Council Decision 1999/468/EC, having regard to Article 7 thereof and without prejudice to Article 8 thereof.

Justification:


A management-committee is only justified for decisions on strategic guidelines. In order to accelerate the implementation of projects an advisory committee is appropriate for all other decisions.

(Amendment 12) Article 12 (1)

This Regulation shall enter into force on the third day following that of its publication in the Official Journal of the European Communities. It shall apply until 31 December 2006. This Regulation shall enter into force on the third day following that of its publication in the Official Journal of the European Communities.

Justification:

The protection and conservation of tropical forests in the developing countries will remain an ongoing task. It is therefore inappropriate to limit the duration of the regulation.



EXPLANATORY STATEMENT

In its common position the Council incorporated fully 18 of Parliament's amendments at first reading which had been taken over by the Commission and also the content of the first part of Amendment 34. Parliament can only propose those amendments at second reading which had already been adopted at first reading.

In this report not all of the amendments rejected by the Council are reintroduced. Amendments from the first reading which are redundant or which relate to comitology and have been superseded by the new ruling of June 1999 (Decision 1999/468/EC) have not been included.
