With regards to complaints regarding the right of public access to official documents, the Ombudsman shall, following due analysis and all necessary considerations, issue a decision concerning the release or otherwise of said documents, which the concerned institution, agency or body shall deliver within the timeframes provided for by Regulation (EC) No 1049/2001.

If the institution concerned does not follow the recommendation to divulge the said documents, it must duly motivate its refusal. In such case, the Ombudsman shall inform the complainant about the legal remedies available, including the procedures available to refer the case to the Court of Justice of the European Union.
