#### **Paragraph 1**

#### *Joint motion for a resolution*

1. Strongly condemns all forms of sexual violence and physical or psychological harassment and deplores the fact that these acts are too easily tolerated, whereas in fact they constitute a systemic violation of fundamental rights and a serious crime that must be punished as such; stresses that impunity must end by ensuring that perpetrators are prosecuted;

#### *Amendment*

1. Strongly condemns all forms of sexual violence and physical or psychological harassment and deplores the fact that these acts are too easily tolerated, whereas in fact they constitute a systemic violation of fundamental rights and a serious crime that must be punished as such; stresses that impunity must end by ensuring that perpetrators are prosecuted; ***calls for any immigrant or refugee convicted of sexual harassment, sexual assault or rape to be expelled immediately from EU territory and to be sentenced in his or her country of origin;***
