MINUTES

Meeting of 1 December 2008, from 15.00 to 18.30

BRUSSELS

The meeting opened at 15.00 on Monday 1 December 2008, with Marcin Libicki, chairman, in the chair.

1. Adoption of draft agenda (PE 416.307)

The chairman announced that Alexandra Dobolyi and Michael Cashman had sent their apologies for absence due to other Parliamentary business. He also announced the presence of Ann Abrahams, the British Parliamentary Ombudsman, who would make a statement and participate in the discussions concerning the follow-up to the report on Equitable Life (item 5). For that item the main petitioners, Paul Braithwaite and Leslie Seymour, would be present, as would Rüdiger Krege, who had submitted petition 208/2006 on a similar issue (item 6). Petitioners would also be present for items 4, 7, 8, 9, 10 and 18. Carlos Carnero González, rapporteur for the opinion on Guidelines for a proposal of a regulation of EP and Council on implementation of the citizen's initiative, pursuant to Art 11 (4) of the treaty on EU (item 18) would be absent for parliamentary reasons. The rapporteur for AFCO's report, Sylvia-Yvonne Kaufmann, would nevertheless be present and take the floor. As far as the "B" items were concerned, items 57, 58 and 62 would be discussed as "A" points at a later meeting.

2. Chairman's announcements

The chairman proposed to close petition 816/2005 by Michael Sachanides, as all correspondence to him had been returned by the post office and no new address had been notified. He also suggested that petition 0008/2007 by Campbell McPherson remained closed following further investigation by the secretariat based upon additional information provided by the petitioner who had requested that his petition be re-opened. Following consultations with the Commission no sufficient grounds to accede to this request had been identified.

The chairman requested the re-opening of petition 0188/2006 by Anna Krazucka (Polish), on behalf of 'Izba Pracodawców Polskich' (Polish Employers' Association), concerning alleged infringement by the Polish and German authorities of EU provisions governing social security schemes for employed persons and their families moving within the Community, for which

the petitioner would be Tomasz Major, president of the Polish Employers' Association. (*Tomasz Major has nevertheless already submitted a similar petition under his own name, which has been registered under number 1198/2008*). Members agreed.

3. Other business

There was no other business.

4. Presentation of petition N° 1616/2008 concerning the employment regime of policemen in France

The petitioners submitted their petition and their representative, Karine Bougard Cerfontaine, made a short statement. The petition will pursue the normal course.

Speakers: the chairman, Ann Abraham, UK Parliamentary and Health Service Ombudsman, who referred to the main points in the memorandum, she had submitted to the committee, Mairead McGuinness, Diana Wallis, Sir Robert Atkins, Kathy Sinnott, Paul Braithwaite (petitioner), Leslie Seymour (petitioner) and Alan Beverly (Commission's representative).

Decision: The chairman would write to the president, Hans-Gert Pöttering, informing him of the discussion and asking him to write to the Chancellor explaining the European Parliament's point of view and addressing the question of compensation to the victims. The chairman would also write to the Public Administration Select Committee of the UK Parliament. A copy of this letter would be transmitted for information to Gerardo Galeote, chairman of the Conference of Committee Chairmen.

6. N° 508/2006 by Rüdiger Krege (German), on behalf of Poly-Markt GmbH, on alleged breaches of EC law by the British insurance company Clerical Medical Investment Group Limited

Speakers: the chairman, Rüdiger Krege (petitioner), Christian Hindahl (petitioner), Heinz Zündel (petitioner), Alan Beverly (Commission's representative) and Diana Wallis.

Decision: Consideration of the petition would remain open pending further information from the Commission. The chairman would write to the German authorities expressing the committee's concern.

7. N° 795/2007 by Latchezar Popov (Bulgarian), on behalf of the Holy Synod of the Bulgarian Orthodox Church, on alleged violations of the European Charter of Human Rights concerning religious freedom, private property, entitlement to a fair trial and social rights

Speakers: the chairman, Bishop George Gervasy (representing the Holy Synod of the Bulgarian Orthodox Church), Aristotelis Gavriiadis (Commission's representative), Kathy Sinnott, Margrete Auken and Victor Bostinaru.

Decision: Consideration of the petition would remain open pending further information from the Commission. The chairman would write to the Bulgarian authorities expressing the committee's concern and to the Commissioner responsible asking that the Commission make a profound inquiry into the matter and expressing the committee's dissatisfaction with the Commission's reply.

8. N° 1282/2007 by Mr. Rémi Sallé (French), on behalf of 4CASP Association, on the environmental impact of a bridge project over Loire, East of Orléans, in the context of the ring-road around Orléans ("le grand contournement")

and

9. N° 37/2005, by Mrs Laurence de la Martinière (French, on behalf of the association A.D.I.P.H.C.M., on the construction of a major motorway bypass round the city of Orléans

Item 8 and item 9 were discussed together.

Speakers: the chairman, Rémi Sallé (petitioner), Thierry Soler (member of "Conseil général du Loiret"), Jean-Marie Salomon (petitioner), Jean-Louis Sénotier (petitioner), Christian Masson (petitioner), David Grimeaud (Commission's representative), Maria Anne Isler Béguin and Margrete Auken.

Decision: Consideration of the petitions would remain open pending further information from the Commission. The chairman re-affirmed the Committee's views as expressed in the recommendations of the report of the fact finding visit and opposition to the construction of a bridge at Mardie. The chairman would write to the French Minister of Environment. It has to be noted that "Schéma de cohérence territoriale (SCoT)" has also expressed its reservation about the project.

10. N° 637/2008 by Pawel Szczepanski (Polish), and one co-signatory, on safe one-way syringes

Speakers: the chairman, Pawel Szczepanski (petitioner), Piotr Zurawski (petitioner), Manfred Kohler (Commission's representative), Victor Bostinaru and David Hammerstein Mintz.

Decision: Consideration of the petition would remain open pending further information from the Commission. The chairman would forward the petition to the Committee on the Environment, Public Health and Food Safety for information.

Tuesday 2 December 2008

14. Coordinators meeting (9.00 - 10.00)

The meeting opened at 10.02 with Marcin Libicki, chairman, in the chair.

15. Chairman's announcement concerning coordinators decisions

The chairman announced the following:

1. Items for which the Committee had been consulted for an Opinion:

- Commission: 25th Annual Report on Monitoring the Application of Community Law. (COM(2008)777 final - 18-11-2008)
- Communication from the Commission on implementing European Community Environmental Law (COM(2008)773/4)

The ALDE Group had been designated for these opinions.

2. Petition concerning Human Rights and Democracy in Belarus:

A petition signed by tens of thousands of persons had been handed to the president, Hans-Gert Pöttering, at a special meeting with the Chairman of the Belarus Delegation and the Chairman of the Petitions Committee. In order to follow up on this event it had been decided to try to organise a joint meeting of the Committee with the EP Belarus Delegation, possibly during a part-session of the Parliament in Strasbourg, possibly in February or March, to which the key petitioners, including the Sakharov Prize-winner, would be invited.

3. Re-launch of an expert study on property ownership in Romania, Bulgaria and the Western Balkans:

Given the large number of petitions received and the fact that the last attempt to order an external study came to nought, the terms have been revised slightly. The coordinators had agreed to the revised proposal so that the procedure finally could get under way.

4. Busutil "City Guide" Report:

This issue, which had been subject to an exchange of letters, would be considered by the Conference of Presidents again during the week (week 49). The coordinators agreed to address the president, Hans-Gert Pöttering, once again on the matter.

5. Follow-up to Open Source petitions:

The coordinators had concluded that the decision concerning an external study on the advantages and disadvantages of open source software for the Parliament and its activities was under the exclusive competence of the Bureau. The chairman would address the president, Hans-Gert Pöttering, expressing the committee's view.

6. Petition 358/2006 by Paul Rодitilev:

The petitioner, who remains dissatisfied with the results of the Committee's attempts to respond to his concerns (it had been decided to close the petition at the May meeting), had contacted the Secretariat at several occasions. The coordinators authorised the secretariat to write to the petitioner confirming the decision.

Speakers:

Carlos José Iturgaiz Angulo, who referred to petition 651/2008 by Jose Miguel Gonzalez Cruz (Spanish), on behalf of 'Asociacion de Vecinos Huerta de la Salud', on the planned removal of 229 trees from the garden of Prado de San Sebastian (Sevilla), requesting that the recommendation was changed from inadmissible to admissible and the Commission asked for information. The chairman stated that he had met the petitioners and that he was of the same opinion. Members agreed.

16. Opinion on Guidelines for a proposal of a regulation of EP and Council on implementation of the citizen's initiative, pursuant to Art 11 (4) of the treaty on EU

Rapporteur: Carlos CARNERO CONZÁLEZ (PSE)

The rapporteur for the opinion was absent for parliamentary reasons, but Sylvia-Yvonne Kaufmann, rapporteur for AFCO's report, took the floor and gave a short presentation of the main points of her report. The chairman announced that the final text of the opinion would be available at the meeting 19-20 January 2009.

17. N° 1029/2007 by Mr Freddy Kerr (Irish) concerning flooding and other problems related to the proximity between his farm and the N4 road (Longford County)

Speakers: the chairman, Helmut Bloech (Commission's representative), Kathy Sinnott and Manolis Mavrommatis.

Decision: Consideration of the petition would remain open pending further information from the Commission.

18. N° 1277/2007 by Marcelino Abraira Piñeiro (Spanish), on behalf of the Comunidad de Propietarios de la Colonia el Pisón, protesting against the construction of a sewage treatment plant in the immediate vicinity of their residential estate in Gijón
