

Justification

The functioning of the fund has proved to be highly problematic, bureaucratic and inefficient in returning people to employment. This position is supported by the Commission's own figures in the Mid-Term evaluation, with the average re-employment rate before the 2009 amendment below the 50% target proposed by the Commission for the new EGF. In addition it offers little value to the European taxpayer, does not add sufficient value to Member State policies, disincentivizes Member States efforts aimed at reform, tries to fix long term structural problems with short term solutions and subsidizes large companies which are supposed to absorb relocation costs. The most effective policy would be to move workers from declining industries and sectors to growing ones, driving job creation, innovation and growth.
