**MINUTES**

Meeting of 2 June 2016, 9.00-12.30 and 15.00-18.30

BRUSSELS

The meeting opened at 9.04 on Thursday, 2 June 2016, with Ms Cecilia Wikström (Chair) presiding.

**1. Coordinators' meeting (*in camera*)**

**2. Adoption of agenda**

The Chair announced that Item 53 on the B list (*Petition No 2333/2014 and Petition 2341/2014*) was cancelled due to further information received from the EC indicating that the petitions should not be closed.

The agenda was adopted with no objections.

**3. Approval of minutes of the meeting of 18 and 19 April 2016**

The minutes of the meeting of 18/19 April 2016 were approved, with no objections.

**4. Chair's announcements**

None.

**5. Any other business**

Members Sotirios Zarianopoulos and Notis Marias asked for Item 51 on the B list (*Petition No 2214/2014*) to be taken out of the B list. Mr Zarianopoulos asked that the EC express an opinion on whether the convention about the write-off of the German debt is compatible with EU law. Mr Marias made reference to the fact that the petition was deemed admissible and the Coordinators decided to keep it open until 8 September 2016 (according to the 2 months rule). The Chair confirmed this and also informed that letters were sent to the respective Permanent Representations.

6. **Petition 0446/2007 by Harry Shindler (British), on the right of British citizens living abroad to vote in national parliamentary elections and**  
**Petition 0967/2012 by Jacqueline Cotterill (British), bearing 4 signatures, on the disenfranchisement of EU citizens exercising their right to free movement and discrimination based upon nationality under the Charter of Fundamental Rights and**  
**Petition 0557/2015 by R. C. (British) on the UK referendum on EU membership**

Speakers: Jacqueline Cotterill (petitioner), Jacquelyn MacLennan (petitioner), Monika Moshammer (EC DG JUST), Jude Kirton-Darling, Ángela Vallina, Pál Csáky, Margrete Auken.

Decision: Keep the petitions open until the publication by the EC of the 2016 European Citizenship Report (expected in autumn 2016). Send a letter to the Permanent Representations of Denmark, Ireland, Cyprus, Malta, UK, Germany and Austria, pointing out that their legal systems currently may result in their citizens residing in another Member State for a certain period of time losing their voting rights as a consequence of exercising their fundamental right to free movement in the European Union, a situation that needs to be resolved in order to enable these disenfranchised citizens to vote in respective national elections.

The possibility of an oral question could be submitted to decision by the Coordinators.

## **9. Chair's announcements concerning Coordinators' decisions**

### **1. Adoption of draft agendas for 20-21 June and 13-14 July 2016**

Requests for later agendas

The draft agenda for 20-21 June 2016 had been adopted through a written procedure on 23 May 2016 due to the short time between the Coordinators' meetings. The draft agenda for 13-14 July 2016 was adopted.

The Coordinators adopted the following requests, which will be taken into account in the respective meeting agendas:

- Petition 246/2016 against the authorisation to build a plant for the disposal of used tyres will be treated by urgency procedure and will be included in the PETI agenda on 20-21 June, requested by EPP;
- Petition 187/2015 on the protection and administration of European agricultural land as shared wealth, requested by Greens/EFA will be included in the PETI agenda either on 20-21 June or on 13-14 July;
- Petition 1049/2015 on the revision of the Multiannual Financial Framework requested by S&D, will be included in the PETI agenda on 13-14 July; BUDG and EMPL committees will be informed about the inclusion of this item on the agenda;
- The proposal by Soledad Cabezón Ruiz for a pilot project on bullying to be proposed to the general budget will be voted on 13-14 July, to be tabled to the general budget in the name of PETI;
- Petition 259/2016 on a hotel construction in La Tejita, Canary Islands will be treated by urgency procedure and will be included in the PETI agenda on 13-14 July, as requested by GUE-NGL;
- Petition 603/2016 on the closing of the milk plant Lauki in Valladolid (Spain) will be treated by urgency procedure and will be included in the PETI agenda on 13-14 July, as requested by EPP and S&D;
- Agenda item No. 32 (Petition 410/2014 by Roberta Metsola on the installation of a floating storage facility for liquefied natural gas in Marsaxlokk Bay in Malta and the risks posed to residents) was postponed to a future meeting;

- Petition 1205/2015 on the modernisation of the Slovakian railway road section at Liptovský Mikuláš, requested by ECR will be included in the meeting agenda in October 2016.

## 2. Reports and opinions

Coordinators appointed Ángela Vallina (GUE-NGL) as rapporteur for the PETI annual report 2015.

## 3. Contested recommendations

The compromises proposed by the Chair were adopted for the following petitions: 1062/2015, 1070/2015, 1158/2015, 1221/2015, 1226/2015, 1270/2015, 1271/2015, 1307/2015, 1318/2015, 1319/2015, 1228/2015, 1348/2015, 1360/2015, 1400/2015, 1407/2015, 1418/2015, 1421/2015, 1427/2015.

The following recommendations were modified:

- 1176/2015: declare admissible, collect all the petitions related to the issue, ask the European Commission for information, bring the issue to the Committee as a join package with all the petitions related to age discrimination at the Public Administration recruitment processes;
- 1372/2015: declare admissible, ask JURI for an opinion on the possible retroactive application of a CJEU judgement;
- 1315/2015: declare admissible, ask the Commission and the Slovak Permanent Representation for more information.

## 4. Requests concerning B-items

Coordinators decided that regarding the requests of specific follow-up proposed by Members on items which were originally proposed to be closed, the following action shall be taken:

- Petition 1199/2011: keep open and include in a future agenda together with Petition 1288/2014;
- Petition 584/2014: keep open until the PETI Hearing on the obstacles to the EU Citizens freedom to move and work in the Internal Market in October;
- Petition 1998/2014: keep open and ask the Commission to re-investigate the matter in the light of the new data protection regulation;
- Petition 108/2015: keep open, ask AGRI and IMCO for an opinion.

The following items will be closed with no further action:

The Coordinators agreed to send for information to the committees mentioned and then close the following petitions:

Coordinators decided that Petition 1832/2012, initially included in the Annex to the Chair's Notes, shall be closed.

## 5. Workshop on disabilities

Coordinators agreed to request the Policy Department C to organise a workshop on disabilities on 9-10 November 2016 with the aim to present an update of the existing study on disabilities and possibly other studies. The workshop should look into the global situation in EU countries.

## 6. Public hearings

Coordinators approved of the programme of the Hearing on Transparency on 21 June 2016 with the addition of Mr. Emilio Di Capitani as a speaker.

Regarding the Hearing on the obstacles to the EU Citizens freedom to move and work in the Internal Market, which is to take place on 11 October 2016, Coordinators were invited to submit proposals concerning topics and speakers by 29 June 2016.

## 7. Report back from the AFCO Working Group on Rules of Procedure

The Chair reported back of the Working Group meeting of 12 May and of her meeting with Mr Wieland, chair of the Working Group, of 1 June 2016.

Coordinators discussed in detail critical points, namely short resolutions, fact-finding visits and the rule on the election of the European Ombudsman.

EPP did not support the compromises regarding short resolutions and the rule on the election of the Ombudsman. GUE-NGL and ECR opposed the requirement of intention to submit a petition. As for the fact-finding visits, the majority supported the compromise proposed by the Chair ("head of the delegation coordinates and seeks consensus...") whereas the Greens did

not agree to this. The final texts are presented in a separate document.

#### 8. Requested non-papers by the Legal Service

Coordinators took note of the non-papers prepared by the Legal Service, i.e. on the admissibility of petitions when they refer to court judgements or cases pending before courts, and on Members' right to petition as requested by PETI following the last Coordinators' meeting on 18 April.

The non-papers will be taken into account in PETI's work in the future.

#### 9. Fact-finding visit to Slovakia

The preliminary programme of the fact-finding visit to Slovakia on 22-23 September 2016 was endorsed and the composition of the delegation was approved with 6 Members and 3 ex-officio Members.

#### 10. PETI Network: information on the questionnaire to Committee secretariats

Coordinators took note of the results of the questionnaire and were invited to make further amendments to the Guidelines, if needed, by 9 June.

Decision on the guidelines will be taken in the June 20-21 or in the July meeting.

The item was postponed to the next meeting.
