**MINUTES**

Meeting of 8 September 2016, 09.00-12.30 and 15.00-18.30

BRUSSELS

The meeting opened at 09.09 on Thursday, 8 September 2016, with Cecilia Wikström presiding.

**10. Chair's announcements concerning Coordinators' decisions**

The Chair announced the following decisions taken by the Coordinators

At their meeting, the Coordinators took the following decisions:

1. Requests for agendas

The Coordinators *adopted* the modified draft agenda for 10 -11 October 2016.

The Coordinators meeting and consideration of the report “Annual report of the activities of the Committee on Petitions” as well as opinions on “The interpretation and the implementation of the interinstitutional agreement on Better Law-Making” and “The Approximation of the laws, regulations and administrative provisions of the Member States as regards the accessibility requirements for products and services” will take place on Monday afternoon.

The vote on the opinion on “EU options for improving access to medicines” will be postponed until November meeting.

Petitions 2715/14 and 0755/13 will be included in the October agenda.

Petitions 0019-16, 0020-16 and 0021-16 will be dealt with during the November Committee meeting.

Coordinators will decide on the inclusion of the petitions 1215/2015 and 1216/2015, on an accident near Santiago de Compostela in their subsequent meeting, depending on the availability of meeting time.

2. Reports and opinions

Coordinators took note of information on the request for the application of Rule 55 on the AFCO report “The implementation of the Charter of fundamental rights of the European Union in the EU institutional framework” and as consequence, of the postponement of the appointment of rapporteur.

3. Contested recommendations

The compromises proposed by the Chair were adopted for the following petitions: 0211/2016, 0213/2016, 0243/2016.

For the petition 0249/2016 the compromise by the Chair was approved with an addition: send to EC for information.

#### 4. Requests concerning B-items

The decision on closing the petition 2214/2014 was taken after an exchange of views by vote with 20 votes in favour of closing 14 in favour of keeping open, no abstentions.

#### 6. Principles relating to the participation of other than petitioners and those representing public authorities in consideration of petitions

Coordinators held an exchange of views and agreed on the full observance of the PETI Guidelines in this matter that stipulate a prior agreement by the Coordinators.

#### 7. Planning of the first half of 2017: Public Hearings and Delegation visits

The groups were invited to coordinate their proposals for Fact Finding Visits and Hearings in the first Semester 2017 so that on 11 October a decision on maximum of 2 visits and 2 hearings can be taken.

#### 8. Fact-finding visit to Slovakia (22-23 September 2016) and Italy (2-4 November 2016)

Coordinators approved the program and the list of participants of the visit to Slovakia and the preliminary programme for the visit to Italy, Taranto.

9. Updated draft programme for the hearing on “Obstacles to EU citizens' freedom to move and work in the Internal Market, as presented by petitioners to the European Parliament”.

Coordinators approved the updated draft programme for the hearing.

10. Solar energy - follow-up of the discussion on petitions on solar energy

Coordinators decided to proceed with a short resolution on this subject. A draft would be prepared for a meeting in November with the aim to adopt it in committee in January 2017.

11. Petitions on the UK referendum and related topics - update

The Chair updated the Coordinators about the current situation with regard to the petitions on the UK Membership referendum.

Coordinators took note of the document prepared by the Policy Department C.

Coordinators agreed to table jointly amendments to the Corbett report on Rules of Procedure.

Speakers: Notis Marias, Sofia Sakorafa and Kostadinka Kuneva, on the closure of petition 2214/2014.

Mr Marias expressed his disagreement with the decision taken after a vote to close the petition, by referring to an earlier decision by the Coordinators to declare the petition admissible and to ask for information from the Commission. In his view, the Committee should have kept the petition open and asked the German and Greek governments to give a response to the issues raised in the petition, as they have not done that until now. He argued

that there was a real connection between the EU and war reparations, and therefore the Committee should continue to deal with it. He also announced his plans to lodge a new petition on the same topic and ask it to be treated in an urgency procedure. In case it was declared inadmissible, he would take the Committee to the European Court of Justice on the violation of his right to petition.
