12. Chair's announcements concerning Coordinators' decisions

1) Adoption of the September agenda and requests for later agendas

The draft agenda for 7 September was adopted.

It included the consideration of petition 0099/2017 on the employment situation of hotel maids and petitions 0130/2017, 0131/2017, 0134/2017, 0154/2017 and 0155/2017 on the Canary Islands on the condition that the Commission replies are available (if no reply on time, these petitions will be put to a later agenda).

Petitions 1304/2016 (lecturers in Spanish universities), 0161/2017 (ECB practices), 0090/2017 (road infrastructure in protected areas), 1468/2016 (regional motorway in an earthquake zone) and 1525/2016 (ETA in Spain) will be placed in the October agenda - all these inclusions are subject to the availability of the Commission replies (if no reply on time, the petition will be put to a later agenda).

Petition 0408/2017 will not be dealt with under urgency procedure, since it is due for adoption in a normal procedure in the end of August.

2) Reports and opinions

None.

3) Contested recommendations

Chair's compromises were approved for petitions 0163/2017 and 0176/2017 (both petitions were closed, with relevant information to be provided to the petitioners; petition 0163/2017 will be sent for information to Parliament's Intergroup on the Welfare and Conservation of Animals).

Petition 0148/2017 will remain open and information will be asked from the Commission.

All other contested recommendations were approved according to the compromise proposed by the Chair.

4) Requests concerning B-items

Petitions 0494/2016, 0806/2014, 0177/2015, 0440/2016, 1073/2016 were closed.

Petitions 0199/2015, 0277/2016, 0465/2016, 0718/2016, 0884/2016, 0888/2016 will be kept open. Petition 1331/2012 will be kept open and put to a future PETI agenda. Petition 0984/2016 will be kept open while awaiting the study on management plans for large carnivores and a reply to a letter to be sent to the Spanish government asking for information on new wolf population figures.

5) Fact-finding visits and hearings

Updates for the FFVs to Taranto and to Larnaca were presented.

The title of the hearing on “Protection of temporary workers’ fundamental rights” will be modified into the following: *“Protection of the rights of workers in temporary or precarious employment, based on petitions received”*.

Coordinators were invited to provide, by 4 September, proposals for hearings and FFVs in the 1st half of 2018.

6) Brexit

A global follow up will be provided to all petitions which were on the agenda of the PETI meeting on 21 June (send the Policy Department study to the EP steering group on Brexit and the Commission, and a letter to the UK authorities).

No further action is expected from PETI for the time being concerning Brexit resolutions.

7) Greens/EFA request for a short resolution on Discrimination

Coordinators mandated the Secretariat to prepare a draft for a short resolution on discrimination as a follow-up to the hearing “Fighting against discrimination of EU citizens in the EU Member States and protection of minorities”, held on 4 May.

8) GUE-NGL request on the elaboration of a report on mortgages and the problem of housing in the EU under the scope of petitions received

Coordinators agreed to table an oral question to plenary (no resolution) as follow-up to the resolution on mortgages which was adopted in 2015. The oral question should deal with the implementation of Directive 93/13/EEC in the European context and not in one country only.

9) Update of the study on the Facilitation Directive

Coordinators decided to commission an update of a study, prepared for LIBE in 2015 by the Policy Department C, on the Facilitation Directive.

10) Joint meeting with FEMM on gender issues, in particular on violence against women

Coordinators agreed to develop ways for long-term cooperation with FEMM and to define possible avenues for joint consideration of petitions on issues of mutual interest, such as on violence against women.

11) Report back from the CCC

The Chair gave an oral update (making reference to the inter-institutional agreement on better law-making, the implementation of the Rome declaration, and the revision of the impact assessment handbook).

12) For information: PETI Network meeting at Committee staff level (16 June 2017)

Coordinators took note of the PETI network meeting organised at staff level (secretariat) on 16 June and of the date of the forthcoming meeting at Members' level on 10 October.
