## PROCEDURAL PAGE

At its sitting of 3 September 2002 Parliament adopted its position at first reading on the proposals for a European Parliament and Council regulation on 1. the provision of air navigation services in the Single European Sky ("the service provision Regulation") (COM(2001) 564 - 2001/0235(COD)), 2. the organisation and use of the airspace in the Single European Sky ("the airspace Regulation") (COM(2001) 564 – 2001/0236(COD)) and on 3. the interoperability of the European Air Traffic Management network ("the interoperability Regulation") (COM(2001) 564 – 2001/0237(COD)).

At the sitting of 27 March 2003 the President of Parliament announced that the common positions had been received and referred to the Committee on Regional Policy, Transport and Tourism (15853/2/2002 – C5-0137/2003, 15852/3/2002 – C5-0139/2003, 15854/3/2002 – C5-0140/2003).

At the sitting of 3 July 2003 Parliament adopted amendments to the common positions.

By letter of 22 September 2003 the Council stated that it was unable to approve all Parliament's amendments.

The President of the Council, in agreement with the President of Parliament, convened a meeting of the Conciliation Committee on 14 October 2003.

By letter of 13 November 2003 the President of Parliament informed the Council that it was necessary to extend the period for the work in committee and the deadline for adopting the act, as laid down in Article 251(7) of the EC Treaty.

At its meeting of 9 December 2003 the Conciliation Committee considered the common positions on the basis of the amendments proposed by Parliament.

At the same meeting it reached agreement on joint texts.

At its meeting of 9 December 2003 the Parliament delegation approved the results of the conciliation by nine votes with one abstention.

The following took part in the vote: Giorgos Dimitrakopoulos (Vice-President and chairman of the delegation), Marieke Sanders-ten Holte (rapporteur), Sylviane H. Ainardi, Giovanni Claudio Fava, Konstantinos Hatzidakis, Carlos Ripoll y Martínez de Bedoya (for Charlotte Cederschiöld), Gilles Savary, Ingo Schmitt, Brian Simpson and Ulrich Stockmann.

On 11 December 2003 the co-chairmen of the Conciliation Committee established that the ioint texts had been approved, pursuant to paragraph III.8 of the Joint declaration on practical

#### **EXPLANATORY STATEMENT**

## **Background**

In autumn 2001, the Commission presented a package of legislative proposals with the objective of achieving the goal of a Single European Sky by 31 December 2004. The aim is:

- to improve and reinforce safety;
- to achieve more effective and integrated air navigation services based on demand driven service provision;
- to restructure European airspace as a function of traffic flow, rather than according to national borders;
- to create additional capacity and to increase the overall efficiency of the air traffic management system.

The Single Sky package consists of a framework regulation, which is the subject of a separate report, together with three implementing regulations dealing respectively with the provision of air navigation services, the organisation and use of airspace and the interoperability of the European Air Traffic Management Network. It is these implementing regulations which are the subject of this report.

On 3 September 2002, Parliament adopted a total of 80 amendments at first reading to the implementing regulations. The Council adopted its Common Positions on 18 March 2003. On 3 July 2003, at second reading, Parliament adopted 16 amendments to the "service provision regulation"; 15 amendments to the "airspace regulation" and 1 amendment to the "interoperability regulation".

With regard to <u>service provision</u>, these concerned in particular:

- common requirements for provision of services;
- conditions and duration of certificates for air navigation service providers;
- designation of air traffic service providers;
- date of entry into force of certification and designation provisions;
- recruitment, training and licensing of controllers;
- charges and charging schemes;
- access to data:
- relations between entities providing services to civil and military air traffic.

With regard to the airspace regulation, the amendments concerned in particular:

- conditions under which airspace blocks are to be created, managed and developed in the context of a single operating airspace, and the role of Eurocontrol in this respect;
- the procedure to apply in case of disputes on the definition of cross-border blocks;
- civil-military cooperation and data exchange;
- the timetable for the creation of a European Upper Flight Information Region;
- preparations for a European Lower Flight Information Region.

The amendment to the <u>interoperability regulation</u> concerned the timetable for transitional arrangements.

## Conciliation

Parliament's delegation to the Conciliation Committee held its constituent meeting on 3 September 2003. Its members instructed its Chairman, Giorgos Dimitrakopoulos, the Chair of the committee responsible, Paolo Costa, and the rapporteurs, Marieke Sanders-ten Holte and Claudio Fava, to begin informal negotiations with Council on the package of four proposals. The conciliation procedure was formally opened as an agenda item without debate at a Conciliation Committee meeting on 15 October. An overall agreement was reached at a further meeting of the Conciliation Committee on 9 December, two days before the deadline laid down by the Treaties.

The key points of the agreement reached with regard to the three implementing regulations can be summarised as follows:

#### 1. Functional airspace blocks

This was one of the most difficult issues discussed during the conciliation procedure. Agreement was however reached on the need to involve Eurocontrol in the development of common general principles for the creation of uniform functional airspace blocks.

A compromise was also reached on the sensitive question of the procedure to apply in case of difficulties arising between Member States with regard to cross-border blocks. Parliament insisted that some kind of mechanism should be in place to deal with such situations. Council however insisted that Member States should retain the power of final decision. The agreement reached allows Member States to refer disputes to the Single Sky Committee and requires them to take acount of the Committee's opinion "in order to find a solution". In addition, the Commission made a statement in which it undertakes to review the situation after five years and, if necessary, make proposals for a modification of the system.

## 2. Civil-military cooperation

In addition to the general commitment to civil-military cooperation made in the context of the framework regulation, which applies to the whole package, Parliament obtained further specific concessions with regard to data exchange between <u>all</u> air navigation service providers, airspace users and airports, be they civil or military. Recognition was also given to the importance of cooperation between neighbouring Member States in applying the concept of the flexible use of airspace across national borders.

## 3. Licensing of controllers and certification of service providers

At Parliament's insistence, an article was introduced in the service provision regulation referring to the need for a Commission proposal on the licensing of controllers with the aim of improving the availability of controllers and promoting the mutual recognition of licences.

Provisions were also introduced to indicate that non-discriminatory access to services should be a pre-condition for certification of service providers and to underline safety obligations. Certificates will be monitored regularly and details of the monitoring of compliance with the common requirements for service providers and the conditions attached to the certificates will have to be be included in annual reports on the implementation of the Single Sky to be submitted to the Commission.

## 4. The creation of a European Lower Flight Information Region

Council agreed to the importance of reflecting upon the extension of upper airspace concepts to lower airspace in accordance with a timetable and appropriate studies. In this respect, the Commission will submit a report to Parliament and Council at the latest by 31 December 2006, accompanied if appropriate by a proposal. If such an extension is envisaged, the relevant decisions should be taken before 31 December 2009.

## **Conclusions**

The outcome of the conciliation procedure can be considered very satisfactory from Parliament's point of view. Important concessions were won in particular on the sensitive questions of functional airspace blocks and civil-military cooperation. Council has also accepted a number of amendments of particular importance to Parliament which strengthen the substance of the Regulations and prepare the way for important follow-up action which should make a significant contribution to the realisation and implementation of the Single European Sky. Parliament's delegation therefore recommends that the House approve the joint text agreed in the Conciliation Committee.
