

- having regard to the proposal for a Council decision (12550/2007)¹
- having regard to the Second Additional Protocol to the Agreement establishing an
 Association between the European Community and its Member States, of the one part, and
 the Republic of Chile, of the other part, to take account of the accession of the Republic of
 Bulgaria and Romania to the European Union,
- having regard to the request for assent submitted by the Council pursuant to Article 300(3), second subparagraph, in conjunction with Article 310 and Article 300(2) first subparagraph, first and second sentence of the EC Treaty (C6-0325/2007),
- having regard to Rules 75, 83(7) and 43(1) of its Rules of Procedure,
- having regard to the recommendation of the Committee on International Trade (A6-0361/2007),
- 1. Gives its assent to conclusion of a second additional protocol to the agreement;
- 2. Instructs its President to forward its position to the Council, the Commission and the governments and parliaments of the Member States and the Republic of Chile.
