DRAFT EUROPEAN PARLIAMENT LEGISLATIVE RESOLUTION

on the proposal for a decision of the European Parliament and of the Council on the European Year for Combating Poverty and Social Exclusion (2010) (COM(2007)0797 – C6-0469/2007 – 2007/0278(COD))

(Codecision procedure: first reading)

The European Parliament,

- having regard to the Commission proposal to the European Parliament and the Council (COM(2007)0797),
- having regard to Article 251(2) and Article 137(2) of the EC Treaty, pursuant to which the Commission submitted the proposal to Parliament (C6-0469/2007),
- having regard to Rule 51 of its Rules of Procedure,
- having regard to the report of the Committee on Employment and Social Affairs and the opinion of the Committee on Women's Rights and Gender Equality (A6-0173/2008),
- 1. Approves the Commission proposal as amended;
- 2. Calls on the Commission to refer the matter to Parliament again if it intends to amend the proposal substantially or replace it with another text;
- 3. Instructs its President to forward its position to the Council and the Commission.

Amendment 1

Proposal for a decision Recital -1 (new)

Text proposed by the Commission

Amendment

(-1) The fight against poverty and social exclusion is one of the central objectives of the European Union and its Member States.

Justification

It is important to make clear at the start of the document why there should be such a year.

Proposal for a decision Recital 4 a (new)

Text proposed by the Commission

Amendment

(4a) There is a need for support to be provided for less-favoured regions, for areas with permanent structural disadvantages, for extremely remote regions, for island Member States and for areas that have been affected by recent deindustrialisation or industrial conversion, in order to enable necessary social and economic cohesion to take place.

Amendment 3

Proposal for a decision Recital 5 a (new)

Text proposed by the Commission


Amendment

(5a) In its resolution of 15 November 2007 on social reality stocktaking¹, the European Parliament stressed that the strengthening of social cohesion and the eradication of poverty and social exclusion must become a political priority for the European Union. In that resolution, the European Parliament also welcomed the nomination of 2010 as the European Year for Combating Poverty and Social Exclusion and called on the Commission and Member States to specify and pursue the ambitious objective of reducing poverty in Europe.

Justification

This recital shows the support the European Parliament has given, in an earlier phase, for the European Year 2010.



Proposal for a decision Recital 6

Text proposed by the Commission

(6) Despite these achievements, significant parts of the population *in all Member*States are still suffering from deprivation and limited access to basic services or feel excluded from their societies, and 78 million people live at risk of poverty.

Amendment

(6) Despite these achievements, significant parts of the population are still suffering from deprivation or limited and unequal access to services or are excluded from their societies, and 78 million people in the European Union live at risk of poverty amongst which 19 million are children, which is at least 3 percentage points higher than among adults. The gender gap is about 2 percentage points. Persistent poverty is a worrying phenomenon in Europe which also needs to be tackled more effectively.

Justification

Special attention should be given to child poverty and persistent poverty which are serious problems in the EU.

Amendment 5

Proposal for a decision Recital 6 a (new)

Text proposed by the Commission

Amendment

(6a) Input for the European Year for Combating Poverty and Social Exclusion should also be derived from the Commission's Communication of 30 January 2008 on a Proposal for the Joint Report on Social Protection and Social Inclusion 2008, which contained an assessment of the 2007 Open Method of Coordination on Social Protection and Social Inclusion that focused on child poverty, thus contributing to keeping the issue high on the political agenda.

Justification

To stress the fact that the fight against child poverty should be an important goal of the

European Year 2010 in conformity and continuity with the impetus already given with the 2007 OMC.

Amendment 6

Proposal for a decision Recital 7

Text proposed by the Commission

(7) In addition, there are signs that the issue of deep poverty is becoming more important and the number of people suffering from absolute poverty is increasing, not least because of growing wealth inequalities across the Union.

Amendment

(7) In addition, wealth inequalities *and* severe poverty are matters of growing concern across the Union.

Justification

The purpose is to stress the crucial role of the Member States in providing sufficient economic and social support as a means to combat poverty. Regarding discrimination the focus of the European Year 2010 should be on combating discrimination on all grounds.

Amendment 7

Proposal for a decision Recital 8

Text proposed by the Commission

(8) The fight against poverty and social exclusion is one of the central objectives of the EU and its Member States.

Amendment

(8) The fight against poverty and social exclusion must be pursued both within the European Union, and externally, in accordance with the UN Millennium Development Goals to which the European Union and the Member States have subscribed.

Justification

The UN Millennium Development Goals support the fight against poverty and are therefore a support to the European Year 2010. In addition, in a globalised world, the eradication of poverty within the EU borders is closely linked to the fight against poverty in third countries.

Proposal for a decision Recital 8 a (new)

Text proposed by the Commission

Amendment

(8a) The European Union, Member States and all those involved, should create the necessary synergies between the European Year for Combating Poverty and Social Exclusion and the activities developed around the annual UN International Day for the Eradication of Poverty on 17 October.

Justification

The General Assembly of the United Nation adopted a resolution on 31st March 1993 that this day would be a special UN day paying attention to the eradication of poverty. Synergies should therefore be created between the European Year and the events of the 17th of October.

Amendment 9

Proposal for a decision Recital 9

Text proposed by the Commission

(9) Poverty and social exclusion *take* complex and multi-dimensional forms. They relate to income and living standards, access to good quality health services and other services, *and* educational and work opportunities.

Amendment

(9) The problem of poverty and social exclusion has broad, complex and multi-dimensional forms. They relate to income and living standards, access to good quality health services and other services, including effective social protection systems, housing, the reconciliation of work and family life, educational and decent work opportunities as well as active citizenship. There is therefore a need, at all levels, for a transparent coordination and cooperation system.

Justification

The prevention and eradication of poverty require good quality and financially sustainable social protection systems as well as possibilities for the conciliation of family and professional life. Conciliation enables better integration in the labour market and therefore helps prevent poverty and social exclusion.

Proposal for a decision Recital 9 a (new)

Text proposed by the Commission

Amendment

(9a) The prevention of and the fight against poverty therefore require multidimensional policies at national, regional and local level which ensure a balance between economic growth and social objectives and are complemented by more targeted strategies for particularly vulnerable groups or persons.

Justification

Given the complexity of the phenomenon of poverty, its prevention and eradication requires multi-dimensional policies which will be implemented at all levels of governance and be completed by more targeted policies for vulnerable groups or persons.

Amendment 11

Proposal for a decision Recital 9 b (new)


Text proposed by the Commission

Amendment

(9b) Social exclusion affects individuals' well-being and prevents people from expressing themselves and participating in society. Community and Member State actions and policies should therefore focus particularly on social exclusion.

Justification

The Commission proposal assimilates social exclusion and poverty and the purpose of the amendment is to differentiate these two phenomena in order to be able to tackle them with different policies and actions in appropriate situations.



Proposal for a decision Recital 10

Text proposed by the Commission

(10) The Social Agenda 2005-2010, which complements and supports the Lisbon Strategy, has a key role in promoting the social dimension of economic growth. One of the priorities of the Social Agenda is the promotion of equal opportunities for all as a vector for a more *cohesive* society.

Amendment

(10) The Social Agenda 2005-2010, which complements and supports the Lisbon Strategy, has a key role in promoting the social dimension of economic growth and the active participation of citizens in society and the labour market. One of the priorities of the Social Agenda is the promotion of equal opportunities for all as a vector for social and intergenerational solidarity and the creation of a poverty-free and a more inclusive society.

Justification

This is a further specification of the link between the Social Agenda 2005 - 2010 and the European Year 2010. The later part of the amendment is in conformity with earlier amendments by the European Parliament on the European Year 2007 for equal opportunities for all (C6 0178/2005).

Amendment 13

Proposal for a decision Recital 11

Text proposed by the Commission

(11) In their National Action Plans for Social Inclusion, several countries highlight the high poverty and/or exclusion risk faced by some particular groups, including children, *lone* parents, the elderly, migrants and ethnic minorities, *disabled* people, the homeless, prisoners, women and children who are victims of violence, and severe substance abusers.

Amendment

(11) In their National Action Plans for Social Inclusion, several countries highlight the high poverty and/or exclusion risk faced by some particular groups, including children, early school leavers, single parents, large families, families with a single income, young people, in particular young women, older people, migrants and ethnic minorities, people with disabilities and their carers, the homeless, the unemployed, in particular the longterm unemployed, prisoners, women and children who are victims of violence, and severe substance abusers. National policies and supporting measures targeted at the most vulnerable groups can play an

important role in fighting against poverty and social exclusion.

Justification

The additions are also part of the National Action Plans for social inclusion.

Amendment 14

Proposal for a decision Recital 12

Text proposed by the Commission

(12) If employment significantly reduces the poverty risk for the individual, it is not always a sufficient condition to lift people out of poverty, and the at-risk-of-poverty rate is still relatively high even for those in work. In-work poverty is linked to low pay, low skills, and precarious and often part-time employment, but also to the characteristics of the household in which the individual lives, in terms of the number of dependants and the work intensity of the household. Quality employment is thus essential to lift individuals out of poverty.

Amendment

(12) Although decent employment significantly reduces the poverty risk for the individual, it is not a sufficient condition to lift people out of poverty, and the at-risk-of-poverty rate is still relatively high even for those in work. In-work poverty is linked to low pay, the gender pay and pensions gap, low skills, limited professional training opportunities and combining a job with family and non-secure employment and working conditions, but also to difficult household conditions. Quality employment and social and economic support are thus essential to lift individuals out of poverty.

Justification

The additions are also important when combating poverty.

Amendment 15

Proposal for a decision Recital 13

Text proposed by the Commission

(13) The lack of basic competences and qualifications is also a major barrier to inclusion in society. There is a growing danger of new cleavages in society emerging, between those who have access to lifelong learning to enhance their employability and adaptability, and to facilitate their personal development and

(13) The lack of basic competences and qualifications *adapted to the changing needs of the labour market* is also a major barrier to inclusion in society. There is a growing danger of new cleavages in society emerging, between those who have access to lifelong learning to enhance their employability and adaptability, and to

active citizenship, and those who remain excluded. Those without adequate skills will find it more difficult to enter the labour market and find a quality job, are more likely to spend long periods out of work and, if they do work, are more likely to find themselves in low-paid jobs.

facilitate their personal development and active citizenship, and those who remain excluded and face forms of discrimination. It is therefore of the greatest importance that both employed and unemployed persons with low skills are given opportunities to enhance their skills.

Justification

The amendment refers to flexicurity and to combating discrimination on all grounds as an integral part of the European Year 2010.

Amendment 16

Proposal for a decision Recital 15

Text proposed by the Commission

(15) Key to the successful impact of Community action to fight poverty and social exclusion is the extent to which it enjoys broad popular support. The European Year should act as a catalyst in raising awareness *and* in building momentum. It should help to focus political attention and mobilise everyone concerned in order to drive forward the Open Method of Coordination on Social Protection and Social Inclusion.

Amendment

(15) Key to the successful impact of Community action to fight poverty and social exclusion is the extent to which it enjoys broad popular and political support. The European Year should act as a catalyst in raising awareness, in building momentum and in exchanging best practices between the Member States, local and regional authorities and international organisations involved in the fight against poverty. It should help to focus political attention in the long-term and mobilise everyone concerned in order to drive forward and strengthen the Open Method of Coordination on Social Protection and Social Inclusion as well as promote further actions and initiatives at European and national level in that field, in association with the people affected by poverty and their representatives. In this regard, particular attention should be paid to the implementation, at national level, of Community legislation, in particular that on equal opportunities, non-discrimination and gender equality.

The campaign to address the issue of poverty and social exclusion should be seen as a long-term effort and the action taken during the Year should have a permanent impact.

Amendment 17

Proposal for a decision Recital 15 a (new)

Text proposed by the Commission

Amendment

(15a) The European Year should help improve the coordination between existing programmes and initiatives at EU level on the fight against poverty and social exclusion within the Open method of Coordination on Social Protection and Social Inclusion.

Justification

The European Year should also be used to improve the coordination between existing EU programmes to improve their effectiveness.

Amendment 18

Proposal for a decision Recital 15 b (new)

Text proposed by the Commission

Amendment

(15b) The European Year should also give rise to a process of reflection at national level on the necessity of establishing decent living conditions for all as a means to prevent poverty and promote the exchange of best practices between Member States in this regard.

Justification

The establishment of decent living conditions is a fundamental prerequisite to prevent and fight against poverty and social exclusion and therefore this issue should be high on the agenda.

(17) However, the definition of policy priorities at national level *and their subsequent implementation* should be monitored by the Commission with a view to guaranteeing consistency with the strategic objectives agreed for the European Year and ultimately with the Common Objectives established for the Open Method of Coordination.

Justification

This amendment is to stress that, apart from putting poverty on the political agenda, it is mutually important to stress the need for implementation of policies.

Amendment 20

Proposal for a decision Recital 17 a (new)

Text proposed by the Commission

Amendment

(17a) Good coordination of all the partners contributing at European, national, regional and local level is a fundamental prerequisite to ensuring the effectiveness of the European Year.

Justification

It is important that during and after the European Year all institutions and parties on all levels that have a role to play in combating poverty should be involved.

Proposal for a decision Recital 19 a (new)

Text proposed by the Commission

Amendment

(19a) The European Year for Combating Poverty and Social Inclusion should continue the best practices derived from the European Years on Equal Opportunities for All in 2007 and the European Year on Intercultural Dialogue in 2008.

Justification

It is logical that within the European Year 2010, the best practices of previous relevant European Years are taking into account.

Text proposed by the Commission

a) Recognition — Recognising the right of people in a situation of poverty and social exclusion to live in dignity and to play a full part in society. The European Year **shall** help **in acknowledging** the situation of people experiencing poverty and promoting their effective access to social, economic and cultural rights as well as to resources and services and shall help in combating stereotypes and stigmatisation;

Amendment

(a) Recognition of Rights—In light of respecting fundamental rights, recognising the right of people in a situation of poverty and social exclusion to live in dignity and to play a full part in society. The European Year will help sensitising public opinion by improving knowledge about the situation of people experiencing poverty, paying particular attention to vulnerable groups, and promoting their effective access to social, economic and cultural rights as well as to sufficient resources and quality services and shall help in combating stereotypes and stigmatisation;

Justification

Particular attention should be paid to the situation of vulnerable groups.

Amendment 25

Proposal for a decision Article 2 – paragraph 1 – point b

Text proposed by the Commission

b) Ownership — Increasing public ownership of social inclusion policies and actions, emphasising everyone's responsibility in tackling poverty and marginalisation. The European Year shall foster awareness, participation and engagement, and create new opportunities for ordinary citizens to contribute.

Amendment

(b) Shared responsibility and partnership
— Increasing public ownership of social inclusion policies and actions, emphasising both collective and individual responsibility in the fight against poverty and social exclusion and the importance of promoting and supporting voluntary activities. The European Year will promote the involvement of all public and private actors, inter alia through pro-active partnerships.

Justification

It is important that everyone, including people living in poverty be involved in the fight

It is important to highlight that participation of people experiencing poverty should be an objective per se and not only a horizontal principle.

The European Year *shall* foster a society that sustains and develops quality of life, social well-being and equal opportunities for all regardless of their background, ensuring sustainable development and solidarity between and within generations and policy coherence with EU action worldwide.

Amendment

c) Cohesion — Promoting a more cohesive society by raising public awareness of the benefits for all of a society where poverty is eradicated and no-one is *marginalised*. The European Year *will* foster a society that sustains and develops quality of life, *quality of skills and employment, the well-being of children,* social well-being and equal opportunities for all, ensuring sustainable development and solidarity between and within generations and policy coherence with EU action worldwide.

Justification

The quality of employment is also important to combat in-work poverty and the gender aspect is obviously to be stressed as women tend to be more vulnerable than men to poverty.

Proposal for a decision Article 2 – paragraph 1 – point d

Text proposed by the Commission

d) Commitment — Reiterating the strong political commitment of the EU to the fight against poverty and social exclusion and promoting this commitment at all levels of governance. Building upon the achievements and possible shortcomings of the Open Method of Coordination on Social Protection and Social Inclusion, the European Year shall strengthen the political commitment to the prevention of and fight against poverty and social exclusion and give impetus to further development of the European Union's action in this field

Amendment

(d) Commitment and concrete action— Reiterating the strong political commitment of the EU and the Member **States** to **eradicate** poverty and social exclusion and promoting this commitment and concrete actions at all levels of governance. Building upon the achievements and *potential* of the Open Method of Coordination on Social Protection and Social Inclusion, the European Year will strengthen the political commitment, by focusing political attention and mobilising all interested parties, to the prevention of and fight against poverty and social exclusion and give further impetus to the Member States and the European Union's action in this field.

Justification

Both the EU and the Member States shall commit to the fight against poverty and social exclusion and have ambitious objectives which can be translated into new initiatives both at national and European level.

EXPLANATORY STATEMENT

At the launch of the Lisbon strategy in March 2000, the European Council invited Member States and the Commission to take steps to make "<u>a decisive impact on the eradication of poverty</u>" by 2010. Subsequent European Councils have reaffirmed this objective.

In 2006, 16% (78 million) of the total EU-25 population lived under the poverty threshold. In 2000 within the EU25 about 40 million people (9% of the total) are confronted with persistent poverty. In 2005, within the EU-25 19% (19 million) of the children were at risk of poverty. Although in most Member States the gender gap is decreasing, regarding the poverty and persistent poverty the gender gap is (in 2006) about 2 percentage point.

Background information

The Lisbon European Council of March 2000 set up the Open Method of Coordination (OMC) which provides a framework of political coordination without legal constraints. As such, it underpins the achievement of the Union's strategic goal of sustained economic growth, more and better jobs, and greater social cohesion by 2010. Member States agree to identify and promote their most effective policies in the fields of Social Protection and Social Inclusion with the aim of learning from each others' experiences. This is a flexible and decentralised method, which involves:

In the framework of this flexible and decentralised method, the Member States agree to common objectives and common indicators, prepare national strategic reports and present their evaluation.

Since January 2007, the EU's new integrated programme for employment and social solidarity supports the goals set out in the Social Agenda and contributes to the Union's wider strategy for jobs and growth.

The overarching objectives of the OMC for social protection and social inclusion are to promote:

- Effective and mutual interaction between the EU's Sustainable Development Strategy and the Lisbon objectives of greater economic growth, more and better jobs and greater social cohesion;
- Social inclusion policies, equality between men and women and equal opportunities for all through accessible, financially sustainable and efficient social protection systems;
- Good governance, transparency and the involvement of stakeholders in the design, implementation and monitoring of policy.

Within the framework of the overarching objectives it is mentioned that the OMC should aim at having a decisive impact on the eradication of poverty and social exclusion.

Following the mandate from the Lisbon European Council, the Member States and the Commission have sought to develop common approaches and compatibility in regard to

indicators. In 2001, the Social Protection Committee (SPC) submitted a report recommending an initial set commonly agreed indicators which was adopted at the Employment and Social Affairs Council in December 2001 and then was submitted to the EU Laeken-Brussels Summit. In June 2006, the SPC adopted an adjusted set of common indicators for the social protection and social inclusion process.

With regard to the objective of eradication of poverty and social exclusion one of the common agreed indicators is the at-risk of poverty rate (share of persons with an equivalised disposable income below 60% of the national equivalised median income).

Summary of the Commission Communication regarding the European Year 2010

In its 2005-2010 Social Agenda, the Commission announced a proposal to designate 2010 as the European Year for combating poverty and social exclusion.

The budget allocated to the Year-17 million euros- represents the highest budget ever granted to a European Year, thus demonstrating its high political importance.

The aim of the European Year is to reaffirm the Union's commitment to solidarity, social justice, greater cohesion, and promote consistency as well as boost support for the overarching objectives of the Union, by making a decisive impact on the eradication of poverty.

The European Year should raise public awareness of poverty and social exclusion in Europe and convey the message that they are disruptive to social and economic development. It should reaffirm the importance of collective responsibility, involving not only decision-makers but also public and private actors.

Apart from the general objectives, four specific objectives underpin the proposal for a European Year for combating poverty and social exclusion:

- Recognising the right of people in a situation of poverty and social exclusion to live in dignity and to play a full part in society.
- Increasing public ownership of social inclusion policies and actions, emphasising everyone's responsibility in tackling poverty and marginalisation.
- Promoting a more cohesive society, by raising public awareness of the benefits for all of a society where poverty is eradicated and no-one is condemned to live in the margins.
- Reiterating the strong political commitment of the EU to the fight against poverty and social exclusion, and promoting this commitment at all levels of governance.

The European Year activities will underpin the Open Method of Coordination (OMC) on Social Protection and Social Inclusion and aim to produce a clear added value in terms of policy impact and effectiveness. Thus the themes of the European Year are in line with this OMC.

While the Union can provide a framework for coordination at various levels, tangible progress will be achieved only through the significant involvement of participating countries at national level. Activities defined at European level to ensure consistency in the approach towards an inclusive society will thus be adapted to the specificities of each country. A Committee made up of Member State representatives will be appointed in order to assist the

Commission in the implementation of the European Year activities.

The Committee will monitor the implementation of the activities on the basis of common guidelines developed by the Commission, the Strategic Framework Document (SFD). National implementation will have to be consistent with the policy objectives set for the European Year, in response to the SFD. Each Member State will submit to the Commission a National Programme for implementing the European Year.

Each programme should be devised, adopted and implemented in strict cooperation with and under the supervision of the National Implementing Bodies (NIBs) designated by the countries participating in the European Year.

When establishing and carrying out their national strategies, each NIB will consult and cooperate closely with a National Advisory Group — NAG — composed of a broad range of stakeholders, including civil society organisations representing the interests of people in poverty, national parliament representatives, social partners, and regional and local authorities.

The experience of previous European Years in the social field has demonstrated their relevance in raising awareness among the general public, fostering participation, enhancing political commitment at all levels and contributing to policy change. The proposal therefore conforms to the principle of subsidiarity set out in Article 5 of the Treaty. At the same time, the proposal for the European Year emphasises how important it is to respect the different traditions and national contexts of the Member States, both to ensure flexible implementation and to avoid interfering with the good practices that already exist in some Member States. In this respect, the proposal also complies with the principle of proportionality.

Core of the Amendments of the European Parliament


The European Parliament, in its report on the Stocktaking of Social Reality, had supported the Commission's proposal for a European Year 2010 with the aim of combating poverty and social exclusion.

In general terms your Rapporteur approves the content of the Commission's proposal and is particularly satisfied with the acknowledgement of the multidimensional aspects of poverty and the necessity to increase public awareness and public and private responsibility as well as the involvement of people affected by poverty and their representatives in the implementation of the Year.

The core of the content of the report is aimed at specifications of the articles and introducing some important new elements. The items that are discussed are:

- 1. Global perspective of poverty and social inclusion by linking the European Year to the Millennium Goals of the UN and especially to the International Day for eradication of Poverty (17th October).
- 2. It should be clear from the start of the European Year that its aim is not only to combat (severe) poverty but also to prevent poverty and social exclusion.
- 3. To further develop the concept of the Commissions' Proposal with regard to the complexity and multi-dimensional aspects of poverty and social exclusion.

 This is done by a more extensive definition of the groups concerned, for example by





introducing early school leavers and (long) term unemployed.

Also there is a further clarification on the multidimensional policies that have to be coordinated and implemented at national, regional and local levels in order to reach the aim of the European Year. These policies should provide equal access to education and lifelong learning including access to ICTs, social protection systems, the quality of social and health services as well as housing.

- 4. A separate point of attention is the need to ensure equal treatment and non-discrimination among others through better implementation of relevant EU legislation, as women and vulnerable groups are confronted with poverty and social exclusion more then others.
- 5. Your rapporteur also wished to give greater emphasis to governance and to the creation of synergies with existing programmes and initiatives.

It is made clear that on an EU level, the Year should not just be used to reiterate previous commitments nor for the mere strengthening of the Open Method of Coordination but that it should give rise to additional efforts in terms of exchange of good practices, the launching of new initiatives etc. For the sake of coherence and continuity of actions, greater links need to be established with the results of previous European Years and coordination with existing European programmes and financial resources that support the fight against poverty and social exclusion needs to be strengthened.

In order to make the European Year a success, national, regional and local authorities need to work together and all relevant actors need to be involved when Member States start to discuss the national content of the European Year.

6. Combined with the previous point, the European Parliament finds it very important that people confronted with poverty and social inclusion, are really involved in the discussions on an EU and national level with regard to the content of and implementation of the plans for the European Year.

This all leads to specific adjustments in the recitals and articles, Specific attention has been given to Article 2 (objectives) and the Annex, part IV, paragraph 2 (themes of the European Year).

In Article 2 the change concerns the involvement and participation of all groups concerned. The Article is also linked to the Annex, part IV. In this Annex the main changes concern the introduction of some additional themes which are aimed at stressing the importance of fighting child poverty in correlation with family poverty, at promoting equal treatment and non-discrimination, active inclusion approaches as well as access to culture and leisure (the purpose is to link the themes with the multi-dimensional aspects of poverty and social exclusion).

OPINION OF THE COMMITTEE ON WOMEN'S RIGHTS AND GENDER EQUALITY

AMENDMENTS

The Committee on Women's Rights and Gender Equality calls on the Committee on Employment and Social Affairs, as the committee responsible, to incorporate the following amendments in its report:

Amendment 1

Proposal for a decision Recital 11

Text proposed by the Commission

(11) In their National Action Plans for Social Inclusion, several countries highlight the high poverty and/or exclusion risk faced by some particular groups, including children, lone parents, the elderly, migrants and ethnic minorities, disabled people, the homeless, prisoners, women and children who are victims of violence, and severe substance abusers.

(11) In their National Action Plans for Social Inclusion, several countries highlight the high poverty and/or exclusion risk faced by some particular groups, including children, lone parents, *large families*, the elderly, *young people and in particular young women*, migrants and ethnic minorities, disabled people, the homeless, prisoners, women and children who are victims of violence, and severe substance abusers.

Proposal for a decision Recital 12

Text proposed by the Commission

(12) If employment significantly reduces the poverty risk for the individual, it is not always a sufficient condition to lift people out of poverty, and the at-risk-of-poverty rate is still relatively high even for those in work. In-work poverty is linked to low pay, low skills, *and* precarious and often part-time employment, but also to the characteristics of the household in which the individual lives, in terms of the number of dependants and the work intensity of the household. Quality employment *is* thus essential to lift individuals out of poverty.

Amendment

(12) If employment significantly reduces the poverty risk for the individual, it is not always a sufficient condition to lift people out of poverty, and the at-risk-of-poverty rate is still relatively high even for those in work. In-work poverty is linked to low pay, low skills, reduced scope for vocational training and for combining a job with a family, precarious and often part-time employment and precarious working conditions, but also to the level of social and economic assistance in relation to the characteristics of the household in which the individual lives, in terms of the number of dependants and the work intensity of the household. Quality employment and social and economic support are thus essential to lift individuals out of poverty.

Amendment 3

Proposal for a decision Recital 15

Text proposed by the Commission

(15) Key to the successful impact of Community action to fight poverty and social exclusion is the extent to which it enjoys broad popular support. The European Year should act as a catalyst in raising awareness and in building momentum. It should help to focus political attention and mobilise everyone concerned in order to drive forward the Open Method of Coordination on Social Protection and Social Inclusion.

poverty and their representatives. In this connection, particular attention should be devoted to the effective implementation at Member State level of Community legislation relating to equal opportunities and equality between the sexes.
