





The European Parliament,

- having regard to the text of the Council (16447/2008),
- having regard to the request for assent submitted by the Council pursuant to Article 300(3), second subparagraph, in conjunction with Articles 310 and 300(2), first subparagraph, of the EC Treaty (C6-0017/2009),
- having regard to Rules 75 and 83(7) of its Rules of Procedure,
- having regard to the recommendation of the Committee on Development (A6-0073/2009),
- 1. Gives its assent to conclusion of the additional protocol;
- 2. Instructs its President to forward its position to the Council and Commission.



EXPLANATORY STATEMENT


The cooperation between the European Union and the Republic of South Africa is established and organised by the Agreement on Trade, Development and Cooperation (TDCA). The accession of Bulgaria and Romania to the European Union on 1 January 2007 requires the conclusion of an Additional Protocol to the TDCA in order to include Bulgaria and Romania as party to the agreement. A simplified procedure for these countries accession to TDCA is provided for in Article 6(2) of the Act of Accession of Bulgaria and Romania, i.e. the Council can conclude the Additional Protocol on behalf of the Member States.

The TDCA itself and all Additional Protocols or amendments to the agreement require the assent of the European Parliament. The modifications made to the agreement through the Additional Protocol only concern the inclusion of Bulgaria and Romania to some Articles on institutional provisions and the inclusion of the Bulgarian and Romanian languages for the purpose of the agreement, e.g. that the invoice declaration is also valid in Bulgarian and Romanian. Therewith, the TDCA is equally authentic in 32 languages (the 22 official EU languages and the 10 official languages of South Africa other than English).

The Commission reviewed the tariff quotas granted under the TDCA on the basis of traditional trade between Bulgaria and Romania. As this traditional trade has been found insignificant, it was considered unnecessary to adjust tariff quotas.

The Additional Protocol containing the abovementioned technical changes concerning the inclusion of Bulgaria and Romania were agreed with the Republic of South Africa, On 9 October 2007 Council adopted a decision on the signing and provision application of the Additional Protocol. The Parliament has now been asked by Council with letter of 13 January 2009 to give its assent to the conclusion of the Additional Protocol.

Your rapporteur considers the Additional Protocol as a purely technical exercise due to the accession of Bulgaria and Romania and recommends Parliament to give its assent.
