If an amendment pertains to an existing act that the draft act is seeking to amend, the amendment heading includes a third line identifying the existing act and a fourth line identifying the provision in that act that Parliament wishes to amend.

Amendments by Parliament in the form of a consolidated text



DRAFT EUROPEAN PARLIAMENT LEGISLATIVE RESOLUTION

on the proposal for a Council decision on guidelines for the employment policies of the Member States (COM(2019)0151-C8-0131/2019-2019/0056(NLE))

(Consultation)

The European Parliament,

- having regard to the Commission proposal to the Council (COM(2019)0151),
- having regard to Article 148(2) of the Treaty on the Functioning of the European Union, pursuant to which the Council consulted Parliament (C8-0131/2019),
- having regard to Rule 78c of its Rules of Procedure,
- having regard to the report of the Committee on Employment and Social Affairs (A8-0177/2019),
- 1. Approves the Commission proposal;
- 2. Calls on the Council to notify Parliament if it intends to depart from the text approved by Parliament;
- 3. Asks the Council to consult Parliament again if it intends to substantially amend the text approved by Parliament;
- 4. Instructs its President to forward its position to the Council and the Commission.
