Kodukohast lahkuma sunnitud isikute abistamine Aasia ja Ladina-Ameerika arengumaades *I**

Euroopa Parlamendi õigusloomega seotud resolutsioon ettepaneku kohta Euroopa Parlamendi ja nõukogu määruse vastuvõtmiseks, millega muudetakse määrust (EÜ) nr 2130/2001 kodukohast lahkuma sunnitud isikute abistamise kohta Aasia ja Ladina-Ameerika arengumaades (KOM (2004)0126 – C5-0097/2004 – 2004/0040(COD))

(Kaasotsustamismenetlus: esimene lugemine)

Euroopa Parlament,

- võttes arvesse komisjoni ettepanekut Euroopa Parlamendile ja nõukogule (KOM(2004)0126)¹;
 - võttes arvesse EÜ asutamislepingu artikli 251 lõiget 2 ja artikli 179 lõiget 1, vastavalt millele komisjon parlamendile ettepaneku esitas (C5-0097/2004);
 - võttes arvesse kodukorra artiklit 51;
 - võttes arvesse arengukomisjoni raportit (A6-0018/2004);
1. kiidab heaks komisjoni ettepaneku;
 2. leiab, et komisjoni ettepaneku bilanss on kooskõlas finantsperspektiivi 4 rubriigi ülemmääraga, eeldades et eelarvepädev institutsioon määrab kindlaks selle summa finantseerimise vahendid finantsperspektiivi raames, arvatavasti teistest valdkondadest ümberpaigutamise kaudu;
 3. palub komisjonil asi uuesti Euroopa Parlamenti saata, kui ta kavatseb ettepanekut oluliselt muuta või seda teise tekstiga asendada;
 4. teeb oma presidendile ülesandeks edastada Euroopa Parlamendi seisukoht nõukogule ja komisjonile.

Position of the European Parliament adopted at first reading on 26 October 2004 with a view to the adoption of Regulation (EC) No .../2004 of the European Parliament and of the Council amending Regulation (EC) No 2130/2001 on operations to aid uprooted people in Asian and Latin American developing countries

THE EUROPEAN PARLIAMENT AND THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty establishing the European Community, and in particular Article 179(1) thereof,

Having regard to the proposal from the Commission¹,

Acting in accordance with the procedure laid down in Article 251 of the Treaty²,

Whereas:

- (1) The European Community is implementing a programme in favour of operations to aid uprooted people in Asian and Latin American developing countries under Regulation (EC) No 2130/2001³. That Regulation expires on 31 December 2004.
- (2) Regulation (EC) No 2130/2001 anticipates that its renewal will depend on the possibility of it being integrated into a single framework Regulation for Asia and Latin America.
- (3) In July 2002, the Commission adopted a proposal for a Regulation of the European Parliament and of the Council concerning Community co-operation with Asian and Latin American countries⁴ which integrates aid to uprooted people in Asian and Latin American developing countries and repeals Regulation (EC) No 2130/2001. *The proposed regulation* might not be adopted in *time to* enter into force by 31 December 2004. Such a situation could jeopardise the continuity and smooth implementation of operations to aid uprooted people in Asian and Latin American developing countries.

- (4) It is necessary to ensure the implementation of Regulation (EC) No 2130/2001 until the entry into force of the future Regulation. The latter would then constitute the new legal framework for operations to aid uprooted people in these two regions.
- (5) It is necessary to indicate the financial framework for the remaining years of the current financial perspective, namely 2005 and 2006.
- (6) It is also necessary to provide for an independent evaluation of the implementation of Regulation (EC) No 2130/2001.
- (7) Regulation (EC) No 2130/2001 should therefore be amended accordingly,

HAVE ADOPTED THIS REGULATION:

Article 1

Regulation (EC) No 2130/2001 is amended as follows:

(1) Artikli 8 lõige 1 asendatakse järgmisega:

"1. Komisjon vastutab käesoleva määrusega reguleeritud meetmete ettevalmistamise, juhtimise ja vastavate otsuste tegemise eest kooskõlas eelarve- ja muude kehtivate menetlustega, eelkõige nõukogu 25. juuni 2002 aasta määruse (EÜ, Euratom) nr 1605/2002, mis käsitleb Euroopa ühenduste üldeelarve suhtes kohaldatavat finantsmäärust artikli 27, artikli 48 lõike 2 ning artiklite 167 ja 242 sätetega.*

(2) In Article 15, the following paragraph 1a is inserted:

"1a. The financial framework for the implementation of this Regulation for the period from 2005 to 2006 is hereby set at EUR 141 *million*."

(3) Artikli 20 lõige 2 asendatakse järgmisega:

"Määrust kohaldatakse 31. detsembrini 2006."

Article 2

This Regulation shall enter into force on the twentieth day following that of its publication in the Official Journal of the European Union.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
