FOR DECISION

1. Giving greater visibility to DROI - press statements

DECISION: The Chair will circulate a consolidated version of his document.

2. Reports and opinion

2.1 INI reports

DECISION: Coordinators decided on the following 2 new INI reports:

- Violation of the rights of indigenous peoples in the world, including land grabbing S&D (3 points)
- Private Military and Security Companies and Human Rights in Third Countries - ECR (3 points). NB: The exact title will be communicated after consultation with SEDE to avoid conflicts of competence.

2.2 Opinion

FEMM Committee

- Women, gender equality and climate justice

DECISION: Coordinators agreed that DROI draft an opinion. Rapporteur: the Chair - 0 points

3. Meeting with National Parliaments 2018

DECISION: Coordinators decided to request authorisation for an Inter-Parliamentary Committee meeting in the first half of 2018 and discussed possible topics as well as the possibility of holding this meeting with AFET and HRAC.

4. Any other business

- **DROI agenda item programming**

DECISION: Coordinators took note of the Secretariat's proposal, allowing for some flexibility for urgent political matters.

- **Follow-up to EP resolutions from the Commission**

DECISION: Coordinators agreed that the Chair write a letter to the Secretary General of the Commission asking for follow-up from the Commission where appropriate.

5. Information

5.1 Missions

- Philippines: authorised with 7 Members plus the Chair
- UNGA with AFET: authorised

The DROI request to send 7 Members + the Chair has been reduced to 4 members + the Chair

- Sudan: authorised with 7 Members plus the Chair
- DROI mission to Saudi Arabia and Bahrain

DECISION: DROI mission to Saudi Arabia and Bahrain - Coordinators agreed to send a letter to the CoP requesting authorisation for the DROI mission to take place in week 44, the first part to be carried out partly in conjunction with DARP.

5.2 Miscellaneous

- Venezuela: The EP ad-hoc mission to Venezuela is currently postponed for political and security reasons
- 8 June 2017: DROI meeting with President Morales - jointly with AFET, Eurolat and D-AND
- 20 June 2017: Joint DROI-AFET meeting on R2P in AFET time-slot
