On 23 November 2017, the European Parliament received a "Draft Commission Implementing Decision amending Implementing Regulation (EU) 2015/2403 establishing common guidelines on deactivation standards and techniques for ensuring that deactivated firearms are rendered irreversibly inoperable". The basic act being Directive (EU) 2017/853 amending Council Directive 91/477/EEC on control of the acquisition and possession of weapons.

The lead committee is IMCO with LIBE associated to it under Rule 54. The reception of this act was communicated to all LIBE Members via the LIBE-Comitology newsletter of 24 November and an internal deadline for proposing an objection was set for 8 December 2017.
