In Case C-616/17 *Blaise and Others – Plant protection products – Regulation (EC) No 1107/2009 – Respect of precautionary principle – Possible submission of observations by the European Parliament*, the committee decided by 4 votes in favour, 14 against and 0 abstentions, to reject the recommendation that Parliament should not submit observations in the proceedings before the Court of Justice.

In Case T-693/17, *Abel García Gómez and Others v Single Resolution Board Resolution of credit institutions - Regulation (EU) No. 806/2014 - Plea of illegality - Possible intervention of the European Parliament*, the committee decided unanimously, by 19 votes in favor, 0 votes against and 0 abstentions to recommend to the President that Parliament intervene in the proceedings before the General Court of the European Union to defend the validity of the Regulation challenged.
