3. Chair's announcements

- The Chair announced that the file included the mission report of the ENVI delegation to Poland on 18-20 September 2017.
- The Chair announced a first informal trilogue scheduled to take place on 25 January 2018, following the adoption of the mandates of the Parliament on 24 October 2017 and of the Council on 20 December 2017 on the Fertilising Products Regulation. IMCO was the lead Committee, but as ENVI had exclusive competence on the issue of contaminants, it has been agreed that the ENVI rapporteur, Ms Gardini, would lead the negotiations on contaminants. The aim of the first trilogue would be to allow a general presentation of the mandates and to delegate a number of issues to technical level. The second informal trilogue was tentatively scheduled for 20 March 2018. ENVI MEPs would be kept regularly informed on the progress of negotiations on the part of the text relating to ENVI exclusive responsibilities.
- **Interpretation status:** corresponded to the standard linguistic profile of the committee: 20 languages were available except for Estonian, Latvian and Gaelic.

- **Web streaming:** The Chair announced that as usual, the meeting file was available electronically via the e-meeting application and that the meeting would be web streamed
- The Chair announced that DG ITEC innovation department had acquired a new camera for 360° video live streaming and would be testing it during the voting session on 24 January 2018, in the afternoon. It would be a controlled experience and the publication of the live video would be made through DG ITEC Facebook account just to highlight the technological side of the experience.
