



**MINUTES**

Meeting of 23 April 2018, 17.00-18.30,  
and 24 April 2018, 9.00-12.30 and 14.30 - 18.30

**BRUSSELS**

The meeting opened at 17:05 with Roberto Gualtieri, Chair, presiding.

**1. Adoption of agenda**

**Decision:** The draft agenda was adopted in the form shown in these minutes.

**2. Chair's announcements**

**EU-Norway VAT agreement**

The Chair informed Members that as no amendments had been tabled to the draft report the Committee would proceed directly to the vote on 24 April.

**Summary of recommendations and decisions following the Coordinators' meeting of 26 March 2018**

**1. INI reports:**

- The order of priority of the INI reports to be drawn up by ECON and which are subject to the "quota" is:

- 1) ECB Annual Report;
- 2) Competition Annual Report;
- 3) EIB Annual Report.

It was also agreed to request a derogation from the decisions related to the CoP decision of 15 March, so that ECON may request authorisation to prepare INIs on all three subjects. Finally, it was agreed to draw up the Annual INI on Banking Union (which is hors quota).

**2. ECB appointment procedures: next steps:**

Coordinators agreed on next steps concerning a dialogue with the Council/Eurogroup with regard to an upgraded role for the Parliament in future ECB appointments, in particular that of the successor to the current ECB President.

### **3. Brexit:**

Coordinators agreed on further elements of their working method in relation to Brexit.

### **4. Former employee of Ernst & Young:**

A summary of information available in the press is to be collected and translated by the secretariat.

### **5. Public hearings:**

- The draft programme of the VAT hearing (24 April 2018) was approved with additions.
- Mis-selling of financial products:
  1. A separate meeting is to be organised with the authors of the studies commissioned by the Policy Department.
  2. The experts at the Public Hearing (19 June) should be made up of:
    - o Two NCAs: France (AMF) and Italy (CONSOB)
    - o One representative of ESAs (EIOPA)
    - o One representative of the Commission
    - o One representative of Better Finance

### **6. ECON visit and delegation:**

- Basel - 16 April 2018: No comments were made on the draft programme.
- US - July: It was agreed that NYC would, together with Washington, be included in the draft programme.

### **7. Economic governance:**

- It was agreed to request facilities for an Extraordinary meeting on Monday 9 July at 15:00, for the Monetary Dialogue and ESRB Hearing, both events with Mario Draghi.
- Coordinators agreed on further elements of the follow-up to EMU December package.
- Coordinators agreed to invite a number of members of the SSM Supervisory Board to an in camera meeting of the BUWG. (*The meeting will take place tomorrow, it will be in camera, i.e. not a public meeting*).

### **8. Possible future studies by the Policy Department:**

In view of the approaching end of the parliamentary term Coordinators decided to request one study only, related to the impact of Regulation (EU) No 537/2014 on costs, concentration and competition in the EU statutory audit market.

### **9. Petitions:**

It was agreed that no follow-up was needed to petitions No 0056/2017 and 0429/2017.

### **10. Motions for Resolution:**

It was decided not to give follow-up to the Motion for Resolution B8-0131/2018 on the collaborative economy.

### **11. Chair's announcements:**

- FEMM INI request: Coordinators agreed to request Rule 55 subject to confirmation that the slot for the INI would be deducted only from FEMM. Anything less than Rule 55 is unacceptable to ECON.
- No objections were raised to the time-slots and formats of the suggested meetings with the Bundestag Finance Committee (19 June) and the joint meeting with EMPL on the Country-specific Recommendations (28 June).

### **12. Any other business:**

IFRS 17: It was agreed that a Motion for Resolution would be tabled for the July plenary.

## **3. Report on ongoing interinstitutional negotiations**

### **Trilogue on the GNI regulation of 10 April 2018**

The first trilogue on the proposal for a regulation on the harmonisation of gross national income at market prices (GNI regulation; Rapporteur Roberto Gualtieri) took place on 10 April. A provisional agreement was reached between the three institutions at that meeting. The Committee will be re-consulted in due course on the provisional agreement in accordance with Rule 69f of the Rules of Procedure. Parliament understands, however, that discussions within the Council regarding the results of the last round of trilogues are ongoing. For the time being, Parliament has not been formally notified of any results of these discussions.

### **Trilogue on the ECN+ regulation of 17 April 2018**

Last 17 April, the first trilogue on the ECN+ file took place. The 3 Institutions agreed on the calendar and the divide between political and technical articles in the proposal for a directive. Most of the issues discussed (safeguards, independence, resources, fines and leniency) have been opened without arriving to an agreement. Next political trilogues will take place the 14 May and the 30 May and, in the meantime, preparatory

work will be conducted at technical level.
