Location of the seat of the European Banking Authority

On 5 June 2018 the 1st trilogue on the Location of the seat of the European Banking Authority (EBA) took place. The co-legislators agreed that:

The location of the seat of the EBA shall not affect EBA's execution of its powers and tasks, the organisation of its governance structure, the operation of its main organisation, or the main financing of its activities;

The Commission shall report every 12 months to the European Parliament and the Council on the compliance with those requirements;

The relocation might allow for the sharing of administrative support services and facility management services among Union agencies which are not related to core activities;

The transfer of the seat of the EBA does not call into question the establishment plan as adopted by the European Parliament and the Council, nor the application of the Staff Regulations to officials or other agents who work at the EBA;

The new premises should be ready and fit for the purpose of permanent relocation by 30 March 2019.

At the next trilogue the co-legislators will address the remaining issue - the involvement of the European Parliament in the selection of the seat of European agencies.

- It was agreed to hold a Structured Dialogue/Exchange of views with VP Katainen on EFSI 3.0/InvestEU if not before the summer recess then in September.
- Regarding the issue of the possible renewal of the mandate of the EFSI Managing Director and Deputy Managing Director, Coordinators agreed that votes are always necessary and this following informal hearings. By way of example, the recent SRB model was cited.
