The meeting opened at 15.09 on Monday, 4 June 2018, with Claude MORAES (Chair) presiding.

 2. Draft Commission Implementing Decision on authorising France to conclude an agreement with Saint-Barthélemy, Saint-Pierre-et-Miquelon, New Caledonia, French Polynesia and Wallis and Futuna respectively for transfers of funds between France and each of these territories to be treated as transfers of funds within France, pursuant to Regulation (EU) No 2015/847 of the European Parliament and the Council. The basic act is Regulation (EU) 2015/847 on information accompanying transfers of funds and repealing Regulation (EC) N°1781/2006
