18. Approval of coordinators' decisions

The Committee approved the decisions taken by the coordinators in the course of their meeting on 21 November 2018, namely that:

1. Coordinators agreed to change the procedure in committee on COM 2018/0614 2018/0322 (COD) on adjustment of annual pre-financing for the years 2021 to 2023, from the simplified procedure (Rule 50) to a normal codecision first-reading procedure. The ECR group will appoint a rapporteur (5 points). The Chair will ask the Commission to re-present its proposal in a future committee meeting.
2. Coordinators discussed the next procedural steps on the MFF-related legislative procedures. They agreed that the Committee should vote on the CPR dossier on 21-22 January; and on INTERREG on 3 December or 21-22 January. They asked the Chair to ask the rapporteur on the ERDF/CF dossier why he favoured a vote on 20-21 February, with a view to perhaps bringing forward this vote if possible. Coordinators decided to return at a future meeting to the question of plenary mandates and possible inter-institutional negotiations.
3. Coordinators took note of a letter from the director responsible for Policy Department B and approved the work programme of studies and research in 2019 proposed in the annex to that letter.
4. The Chair reported back on a short meeting she had held on 20 November with the chair of the TRAN committee to discuss how to proceed on financial aspects of the Connecting Europe Facility proposal.
