Meeting of 4 February 2019, 15.00 - 18.30

BRUSSELS

The meeting opened at 15.14 on Monday, 4 February 2019, with Claude Moraes, (Chair) presiding.

1. Adoption of agenda

The draft agenda was adopted with the following changes:

Daniel Dalton requested a vote pursuant to Rule 205 of the Rules of Procedure on the Coordinators' decision to draft an interim consent report in accordance with Rule 99(5) on the proposal for a Council Decision on the determination of a clear risk of a serious breach by the Republic of Poland of the rule of law

The Chair announced that the requested vote would take place at 16.35 at the beginning of the voting session as a roll-call vote.

Linguistic profile

The Chair indicated that interpretation was available all languages except Croatian,

Danish, and Gaelic.

Delegated and implementing acts

The Chair informed that The Parliament received two Draft Commission delegated acts:

- On 31 January 2019, the Parliament received Draft Commission delegated regulation (EU) of 31.1.2019 supplementing Directive (EU) 2015/849 of the European Parliament and of the Council with regard to regulatory technical standards for the minimum action and the type of additional measures credit and financial institutions must take to mitigate money laundering and terrorist financing risk in certain third countries.

The basic act is Directive (EU) 2015/849 of the European Parliament and of the Council of 20 May 2015 on the prevention of the use of the financial system for the purposes of money laundering or terrorist financing.

The reception of this delegated act was communicated to all LIBE Members via the LIBE DIA Newsletter of 1 February 2019 and an internal deadline for proposing an objection was set. before 14 February 2019 at 12:00.

- On 28 January 2019, the Commission forwarded a draft delegated act under Article 9(2) of the Anti-Money laundering Directive to the European Parliament: COMMISSION DELEGATED REGULATION (EU) .../... of XXX supplementing Directive (EU) 2015/849 of the European Parliament and of the Council by identifying high-risk third countries with strategic deficiencies, including its Annex. The draft act was sent for consultation to the Member State Expert Group on Money Laundering and Terrorist Financing (EGMLTF).

LIBE and ECON coordinators as well as the AMLD negotiation team received the notification of this draft and how to access it via email on 28/01/2019 and were invited to send any comments to the LIBE and/or ECON secretariats by 1 February 2019.

The delegated act as well as the documents with the assessments are subject to a marking "Limited". Distribution is on a need to know basis and they are not for public dissemination.

- Draft Commission Implementing Decision on the specifications for technical solutions to connect central access points to the ETIAS Central System and for a technical solution to facilitate the collection of data by Member States and Europol for the purpose of generating statistics on the access to the ETIAS data for law enforcement purposes, pursuant to Article 73(3)(b) of Regulation (EU) 2018/1240
