- On 9 January 2019, the Parliament received the Draft Commission Implementing Decision and its Annex laying down the specifications for the quality,

resolution and use of fingerprints and facial image for biometric verification and identification in the Entry/Exit System (EES).

The basic act is Regulation (EU) 2017/2226 of 30 November 2017 establishing an Entry/Exit System (EES) to register entry and exit data and refusal of entry data of third-country nationals crossing the external borders of the Member States and determining the conditions for access to the EES for law enforcement purposes, and amending the Convention implementing the Schengen Agreement and Regulations (EC) No 767/2008 and (EU) No 1077/2011.

The reception of this implementing act would be communicated to all LIBE Members via the LIBE DIA Newsletter of 11 January 2019. The deadline for objection has been set before 23 January 2019 at 12:00.

On 8 January 2019, the Parliament received two Draft Commission Implementing Decisions and their Annexes:

- on keeping and accessing of the logs in the European Travel Information and Authorisation System (ETIAS), pursuant to Article 73(3)(b) of Regulation (EU) 2018/1240 of the European Parliament and the Council; and
- on the specifications for technical solutions to connect central access points to the ETIAS Central System and for a technical solution to facilitate the collection of data by Member States and Europol for the purpose of generating statistics on the access to the ETIAS data for law enforcement purposes, pursuant to Article 73(3)(b) of Regulation (EU) 2018/1240.

The basic act is Regulation (EU) 2018/1240 of the European Parliament and of the Council of 12 September 2018 establishing a European Travel Information and Authorisation System (ETIAS) and amending Regulations (EU) No 1077/2011, (EU) No 515/2014, (EU) 2016/399, (EU) 2016/1624 and (EU) 2017/2226.
