1 Adoption of the draft agenda

The agenda was adopted as shown in these decisions.

2 Adoption of the Coordinators Decisions of the last meetings

The decisions of the coordinators meeting of 3 December were approved by written procedure on 18 December 2014.

3 Announcements

3.1 Main items of the Conference of Committee Chairs

a. INI Proposals

The CCC noted the AFET/SEDE agreement for the association of IMCO (Rule 54) on their INI on "The impact of developments in European defence markets on the security and defence capabilities in Europe" with exclusive competence for defence procurement legislation.

b. Committees cooperation on the Investment Plan

Following the presentation by the Commission of the draft Regulation establishing the European Fund for Strategic Investments, the CCC Chair will invite the Chairs of the Committees concerned to agree on the modus of cooperation in preparing the EP position, ahead of the Conference of Presidents on 28 January (mini session week in Brussels).

c. Hearings of Commissioners-designate

AFCO rapporteur Corbett gave a presentation on the lessons to be drawn from the recent experience with the relevant EP hearings. The issues of the time pressure, the evaluation process by individual committees or joint committees as well as horizontal issues regarding the publication of the evaluations and the format of the letters were discussed.

d. *Missions by Committees*

The CCC Chari expressed concern on the recent approach taken by the Conference of Presidents regarding missions by Committees to the Countries of the Presidency and outside the EU. He invited the Committee Chairs to contact their Political Groups to explain the reasons for visits to Countries of the Presidency such as Latvia and Luxembourg in the current semester. He also reminded of the establishment of an "External missions coordination group" to advise the Conference of Presidents who will be authorising missions outside the EU. The Coordination Group is composed of a member representing all Political Groups, the CCC and the CDC Chairs, the Chairs of all the DG EXPO committees and the Chair of any Committee concerned. The next meeting of the Coordination group will take place on 28 January.

JURI proposed on 20.11.2014 to grant IMCO informal association (simple opinion with exclusive competence on matters of the internal market). IMCO has rebutted this with a table stressing why IMCO has the main competence on this topic. CCC will now be making a recommendation and a decision by the COP is awaited on this matter.

However, informal negotiations between the Rapporteurs have been unsuccessful and AGRI has confirmed its request on 19.12.2014.
