



## EU long-term budget: Does the EU have enough resources to finance its priorities?

**September 2023**

*The EU's long term budget, known as the multiannual financial framework (MFF,) sets the annual limits on EU commitments in different policy areas ('headings') and on overall annual payments. The current 2021-2027 MFF was first presented in 2018, but a new proposal was put forward in 2020 to address the social and economic consequences of the COVID-19 pandemic. The 2021-2027 MFF brought along with it the NextGeneration EU (NGEU) Recovery Instrument (a unique financial stimulus package), a new Own Resources Decision, and a conditionality, system, with respect for the rule of law tied to sound financial management of EU funds.*

*The MFF review, to be presented by 1 January 2024, was included in the [declarations](#) annexed to the Council Regulation laying down the multiannual financial framework for the years 2021 to 2027. A revision of the MFF was proposed by the Commission in June 2023. Together with the proposed new own resources, this will be of paramount importance to secure enough resources to equip the EU budget for current and future challenges.*
