## **EXPLANATORY MEMORANDUM**

### **1. CONTEXT OF THE DELEGATED ACT**

The Dutch, Maltese and Slovenian language versions of Implementing Regulation (EU) No 1333/2011 contain an error. In order to align the Dutch, Maltese and Slovenian language versions with the other language versions, a Delegated Regulation correcting Implementing Regulation (EU) No 1333/2011 needs to be adopted.

### **2. LEGAL ELEMENTS OF THE DELEGATED ACT**

This Delegated Regulation corrects errors in the Dutch, Maltese and Slovenian language versions.

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) No 1308/2013 of the European Parliament and of the Council of 17 December 2013 establishing a common organisation of the markets in agricultural products and repealing Council Regulations (EEC) No 922/72, (EEC) No 234/79, (EC) No 1037/2001 and (EC) No 1234/2007<sup>1</sup>, and in particular Article 75(2) thereof,

Whereas:

- (1) The Dutch, Maltese and Slovenian language versions of Commission Implementing Regulation (EU) No 1333/2011<sup>2</sup> contain an error in recital (3), in the first paragraph of Article 1, in Article 3 and in point I of Annex I, concerning the varieties of bananas subject to the marketing standards established in that Regulation. Therefore, a correction of the Dutch, Maltese and Slovenian language versions is necessary. The other language versions are not affected.
- (2) Implementing Regulation (EU) No 1333/2011 should therefore be corrected accordingly,

HAS ADOPTED THIS REGULATION:

*Article 1*

*(does not concern the English language)*

*Article 2*

This Regulation shall enter into force on the twentieth day following that of its publication in the *Official Journal of the European Union*.
