SYSTEMATIC OVERVIEW OF EU LEGISLATION ON CIVIL LIBERTIES, JUSTICE AND HOME AFFAIRS

The European Parliament's Policy Department for Citizens' Rights and Constitutional Affairs is developing the **LIBE Legislative Mapping Project**, in cooperation with the Secretariat of the Committee on Civil Liberties, Justice and Home Affairs (LIBE).

WHAT IS LEGISLATIVE MAPPING?

This long-term project consists of a **comprehensive up-to-date overview of existing and emerging EU legislation and related information in the field of justice and home affairs (JHA)** in the form of an **online tool** for MEPs and their staff.

The Legislative Mapping comprises **a series of general legislative maps in the following policy areas relevant for LIBE**: asylum; data protection; external border management; fundamental rights; judicial cooperation in criminal matters; migration; police cooperation in criminal matters; Schengen; and visa policy. **Each of these general legislative maps is complemented by numerous specific legislative maps, which focus on subtopics of the aforementioned policy areas.**

PURPOSE

The purpose of the Legislative Mapping Project is to **outline and clarify the legislative areas of the LIBE Committee**. It aims to inform decision-making in the JHA policy area and to support a more sophisticated, rounded understanding of the issues involved, with a

view to **ensuring coherence of the acquis** and **better parliamentary scrutiny** of the executive.
