
BACKGROUND

The European Parliament is uniquely placed as a fundamental rights actor. As a colegislator, it has a decisive role in most EU law- and policy-making; its competences on the EU's budget also enable it to play a great role in shaping the fundamental rights policy of the EU. Moreover, it is a privileged litigant before the Court of Justice of the European Union.

In its resolution of 8 September 2015 on the situation of fundamental rights in the European Union (2013-2014), the European Parliament reiterated that it is essential for the European Union, its institutions and the Member States to guarantee the respect and the promotion of the common European values listed in Article 2 TEU and in the EU Charter of Fundamental Rights, both in European and national legislation, public policies and their implementation, while fully respecting the subsidiarity principle.

The European Parliament in its resolution also pointed out that pluralism, non-discrimination and tolerance are among the founding values of the Union. In view of the fact that nowadays in the EU there are cases of discrimination, marginalisation and even violence and abuse against people belonging to certain communities and vulnerable groups, for the European Parliament only policies designed to promote both formal and substantive equality and to combat all forms of bias and discrimination can build a cohesive society.

The objective of the hearing on the situation of fundamental rights in the Union is, within the context of the reports on fundamental rights presented by the Fundamental Rights Agency and the initiatives by the European Commission and the Council of the European Union, to contribute to the on-going dialogue on the mechanisms and methods to better safeguard the fundamental rights of persons in the Union.


