The draft opinion was presented in CONT on 13 June 2016. After the presentation, the deadline for amendments was set for 7 June. The CONT Secretariat received 20 amendments which focus mostly on the recent financial crisis and the possible issues related to further fiscal and economic integration.

Among other, the Rapporteur stressed that the budgetary and fiscal capacity should be established as a part of the Union budget, outside the MFF and implemented by the Commission, within the Union framework. As democratic scrutiny, transparency and accountability to the Union citizens through existing institutions should be ensured for such capacity, the Rapporteur emphasised that it should comply to the discharge procedure as stipulated in the Treaty on the Functioning of the European Union.

#### 6. CONTROL OF THE REGISTER AND COMPOSITION OF THE COMMISSION'S EXPERT GROUPS



#### **Consideration of draft INI report**

Rapporteur: <u>Dennis de Jong</u> (GUE/NGL) Administrator: Philippe Godts

In light of the findings of a study commissioned by CONT and BUDG in 2015 and the need for an adequate follow-up of this issue, the Conference of Committee Chairs approved on 26 November 2015 the CONT-proposal for the elaboration of an own-initiative report on the register and composition of the Commission's expert groups.

During the presentation of the CONT/BUDG study, in September 2015, the services of the European Commission made it known that work had greatly advanced on a revised framework for its expert groups, consisting of (revised) horizontal rules and an improved public register. The Parliament requested to the Commission to wait with the formal adoption of its new framework until it had been able to express its views.

On 1 March 2016, the Rapporteur therefore published a working document for CONT, outlining his main concerns with the existing horizontal rules and register. The Commission services, in their turn, provided the Parliament with a working document in which they reacted to the various recommendations of the Rapporteur.



After new contacts between the First Vice-President of the Commission, the European Ombudsman, NGO's and the three rapporteurs of the European Parliament (i.e. the CONT- and JURI-rapporteurs for the CONT/JURI-report and the BUDG-rapporteur for the BUDG-opinion), the Commission adopted on 30 May 2016 its Decision establishing horizontal rules on the creation and operation of Commission expert groups.

Although the exchanges with the First Vice-President were useful and provided practical solutions for most of the remaining points, the new framework adopted by the Commission did not reflect these solutions. Against this background, the Rapporteur is of the opinion that the adoption of an own-initiative report is still useful in order to enable the Commission to include its recommendations into the implementation guidelines for the Commission services, and to allow the Parliament to request reporting on the implementation of the Commission decision.

The remaining concerns of the Ombudsman, NGO's and the rapporteurs related to, inter alia, the public nature of the deliberations in expert groups, their minutes, and the assurance of a balanced composition in specific cases. In addition, the discussions concentrated on the enforcement of the revised rules and the reimbursement of costs of interest representatives, other than those relating to travel and accommodation.

On 27 April 2016, BUDG committee adopted its opinion on the expert groups.

#### 7. GENERAL BUDGET OF THE EUROPEAN UNION FOR THE FINANCIAL YEAR 2017 - ALL SECTIONS

Commission Vice President Georgieva presented the draft Budget 2017 during the BUDG meeting of 30 June 2016.

In her draft opinion Martina Dlabajová welcomes the programme statements of operational expenditures attached to the draft budget 2017 as they partially respond to the request made by the Parliament concerning the establishment of a performance-based public budgeting model in which each budget line is accompanied by objectives and outputs to be measured by performance indicators.

She insists that as part of the budget authority the Parliament is entitled to express views on those objectives and indicators and that before adopting the budget, the Parliament should scrutinise the European added value of each budget lines. She also stresses the need to simplify the internal management tools of the Commission.



CONT rapporteur is also concerned by the high level of RAL ("reste à liquider") and reiterates the request that the Commission submits a communication to the European Parliament in time for the mid-term review of the Multiannual Financial framework with proposals explaining how it will in future reconcile long-term political objectives such the Europe 2020 Strategy with the future post-2020 MFF.

The draft opinion contains also specific views concerning sectorial policies.

### 8. COMMISSIONERS' DECLARATIONS OF INTERESTS - GUIDELINES

In her draft opinion the rapporteur notes that the Code of Conduct for Commissioners adopted on 20 April 2011 (COM (2011) 2904) presents improvements over the preceding code adopted in 2004. She regrets nevertheless that the 2011 Code of Conduct has failed to address all the recommendations issued by the Committee on Budgetary Control on 2 March 2011 and points out, in particular, that the Commissioners are not required to declare all their financial interests or assets but only such interests or assets

"which might create a conflict of interest in their performance of their duties", that there is no requirement to declare debts and liabilities and that dependent children are not required to produce the same information as spouses.

The opinion also refers to some deficiencies detected in the implementation of the code of conduct and regrets that the Code fails to lay down any divestment requirement or to define the notion of conflict of interest.

# 9. ECA SPECIAL REPORT 8/2016 (2015 DISCHARGE): RAIL FREIGHT TRANSPORT PERFORMANCE IN THE EU: STILL NOT ON THE RIGHT TRACK

The promotion of more efficient and sustainable methods of transport, and in particular rail freight, has been a key part of EU policy for the last 25 years. It started in 2001 with the Commission setting ambitious targets for the market share of the

rail freight, to less aspiring targets established in 2011 with much farer deadline for implementation (2030 or even 2050). The EU's policy objectives for shifting goods from road to rail have been funded by the EU budget, approximately 28 billion euros, between 2007 and 2013. Some projects are financed by the ERDF and cohesion fund under shared management and the co-financing can be provided at rates up to 85%. Others are financed under the TEN-T Programme by the Commission and the co-financing rate varies between 20% and 40%. The former were mainly allocated to road whether the latter was devoted to rail.

The Court concluded that the performance of the rail freight transport in the EU is not satisfactory and for that reason makes clear recommendations to improve the deficiencies. The Commission and the Member States are asked to ensure market liberation in the rail freight sector, namely by preventing anti-competitive practices by infrastructure managers and incumbent railway undertakings. They are asked to adapt the traffic management rules applied by infrastructure managers to the specific needs of the rail freight sector. They are also advised to simplify and harmonise the procedures for vehicles approval and issuance of safety certificates. There should be a regular monitoring of the performance of the rail freight sector and it should be transparent and harmonised. The Commission and the Member States are also advised to promote fair competition between different modes of transport by stressing some externalities which favour the rail transport. It is necessary to have a consistent approach between policy objectives and fund allocations by targeting as a priority those aspects such as bottlenecks and missing rail connections that hamper the objective of improving the performance of the rail sector. The Court also considers necessary to improve the coordination of rail investments from the selection, through the planning till the management of the projects. The Commission agreed with all the recommendations. With regard to the rail network maintenance, the Commission points out that it is a national competence and not eligible for EU funding.

The Rapporteur welcomes the report and endorses the Court's recommendations. He asks for several evaluations to be produced, on one-stop-shop, paths allocation, on freight corridors in parallel with CEF corridors, on the national rail systems interoperability and on MS' transport strategies. The Rapporteur regrets that the EU funds invested could not be considered cost-effective and that the continuation of the state of play in the rail sector will not enable the fulfilment of the shifting targets by 2030. Common and mandatory impact assessment on future rail freight legislation is important as well as the setting of a strategy for rail freight transport. An action plan to support the full and swift implementation of the 4<sup>th</sup> railway package should be put in place.

The Rapporteur's recommendations will possibly be included in the 2015 Commission discharge report.

The TRAN committee will have an exchange of views on the special report later this year.

# 10. ECA SPECIAL REPORT 3/2016 (2015 DISCHARGE): COMBATTING EUTROPHICATION IN THE BALTIC SEA: FURTHER AND MORE EFFECTIVE ACTION NEEDED

The Baltic Sea is one of the world's most polluted seas. In 2009, the European Council adopted a macro-regional strategy aiming to foster environmental protection, reduction of nutrient loads and promoting increased cooperation between countries. In the 2007-2013 period, the EU contribution to waste water

collection and treatment projects in the five Member States bordering the Baltic Sea benefiting from EU support was 4.6 billion EUR. Rural development measures, including water protection, to all eight Baltic Sea coastal Member States amounted to 9.9 billion EUR. In addition, from 2001 to 2014, the EU co-financed projects with a value of nearly €50 million in Russia and Belarus to improve water quality. The ECA visited three Member States with Baltic coasts (Finland, Latvia and Poland) and conducted a survey in all of the other Member States bordering the Baltic Sea. EU-supported projects in Russia and Belarus were checked through documents at the European Commission. The audit examined whether EU action had been effective in helping Member States to reduce nutrient pollution in the Baltic.

The ECA arrived at the conclusion that there has been limited progress towards nutrient reduction in the Baltic Sea; recent data on total annual inputs into the Baltic Sea during the 1995-2012 period showed a downward trend in nitrogen (9%) and phosphorus (14%) inputs. In light of its findings, the ECA recommended that the Commission should require that Member States define programmes of measures which enable them to reach measurable targets for reducing nutrient loads in order to achieve the objectives of the marine strategy framework and the water framework directives; the Member States should collect information on the cost-effectiveness of nutrient load reduction measures in order to have a robust analysis for establishing future programmes of measures and plan and construct their waste water infrastructure as efficiently as possible and, if necessary, consider granting financial support to households which could not otherwise afford to connect to the sewage network.

The Rapporteur's recommendations will possibly be included in the 2015 Commission discharge report.

The mission aims to investigate the use of the European Social Fond and the Youth Employment Initiative in the Italian regions of Sicily and Calabria, within the context of combatting unemployment of young people. In the light of the preparations for this mission, CONT is organising a first preliminary exchange of views with the representatives of the Commission with the aim of exploring the issues likely to be encountered.

# 14. DISCHARGE 2014-INTERNATIONAL FUSION ENERGY ORGANIZATION (ITER)



Exchange of views on ITER Council conclusions, in the presence of *Miguel Arias Cañete*, Commissioner for Climate Action and Energy, and Consideration of draft report

The construction of the ITER fusion machine by the ITER international consortium proves to be much more challenging than initially expected. The Budgetary Control Committee has been monitoring this project for years and voicing its

concerns, as it is responsible for the annual discharge of the Fusion for Energy Joint Undertaking (F4E JU) – a body created to funnel European contributions to ITER.

In April 2016, the Plenary decided to postpone the discharge to Fusion for Energy Joint Undertaking (F4E JU) for the financial year 2014



Since 2014 however significant changes have been made in the ITER project. New management has been chosen both in ITER and in F4E JU and a new action plan has been drafted and presented. In November 2015 the ITER Council, the highest body governing the ITER project, of which the Commission is a member, decided to conduct an independent review of the overall schedule and associated resources and to consider possible additional measures for expediting the schedule and reducing costs. In June 2016 the ITER Council endorsed the updated Integrated Schedule for the ITER Project, which identifies the date of First Plasma as December 2025. The Council stated that the updated Schedule is challenging but technically achievable, duly validated with a thorough and comprehensive review by the independent ITER Council Review Group. A sharp focus on the core elements through First Plasma will effectively reduce project risks. The evidence of increased effectiveness of decision-making, improved understanding of risks, and rigour in adhering to commitments provided a renewed basis for confidence that the project will maintain its current positive momentum.

On 4 July CONT held a meeting with the Mr Johannes Schwemmer, director of F4E JU and Mr Gerassimos Thomas, Deputy Director General, DG Energy, on the position of the JU and the Commission on the changes in ITER.

At this meeting, the Commissioner will present the outcome of the last ITER Council meeting and the rapporteur, Mr Marinescu, will present his draft second discharge report.

In April 2016 CONT decided to postpone the discharge of the Artemis and ENIAC JUs on the basis of the qualified opinion of the Court of Auditors based on the lack of information necessary to calculate neither the weighted rate of error nor a residual error rate following the ex post audits of the National Funding Authorities (NFA's). In his first discharge report the rapporteur invited ECSEL JU (Artemis and

ENIAC have been merged in 2014 and are now part of ECSEL JU) to collect additional and necessary documents and information from the national audit bodies of the Member States and/or national competent



departments, in accordance with the provisions of Article 287(3) of the Treaty of the Functioning of the European Union. On 1 July ECSEL JU has submitted to CONT all the requested information supporting the written statement that the implementation of the national procedures provides a reasonable assurance on the legality and regularity of transactions" as received from the NFA's, covering 96.79 % of the spending in 2014 for ENIAC & ARTEMIS.

# **Consideration of draft report**

For the eighth year, and by a large majority, on 28 April 2016, the Plenary postponed the 2014 European Council and Council discharge, maintaining the decision and reconfirming the content of the report, as voted in CONT.

The rapporteur, Mr Ryszard Czarnecki (ECR), in his second report recalls the outstanding issues and Parliament's responsibilities in the discharge process. He points out those requests made by the Parliament in previous discharge exercises that continue to be unanswered. Among those, the lack of information on the cost of buildings, on the adoption of a code of conduct and on the whistle-blowers' rules as well as on the increase of underspending and carryovers of commitments. The Rapporteur also verified that only three out of twenty seven questions submitted to the Council by CONT Members in relation to the financial year 2014 could find a clear reply in the documents provided by the Council. He regrets that no replies were provided in the meantime by the Council to the questions and the requests made in this and the previous discharge exercises. Also he is of the opinion that it is necessary to consider different possibilities to update the rules on granting discharge laid down in the TFEU. He proposes therefore to refuse again the discharge to the European Council and Council.
