Introductory words by Thomas Händel

This month's committee meeting will take place on 12 and 13 October. There will be a hearing on the Posting of workers in the



framework of the provision of services, a discussion on the European Parliament Pilot Project on Health and Safety of Older Workers and an exchange of views with the new Chair of the European Network of Public Employment Services. The EMPL Committee will also exchange views with stakeholders on the Amendment to Directive 2004/37/EC on the

protection of workers from the risks related to exposure to carcinogens or mutagens at work. Furthermore, the agenda foresees the consideration of the oral questions and motions for resolutions on the European Qualifications Framework for lifelong learning and on Establishing a Skills Guarantee.

I would also like to inform you that the EMPL Working Group on "Monitoring the implementation of labour market and social reforms in Greece under the Memorandum of Understanding" held its third meeting on 29 September. In this context, the recent reforms of the Greek welfare system were discussed as well as the upcoming negotiations on the reforms of the Greek labour market.

Finally, during the September Plenary session, the following reports and recommendations have been adopted: Creating labour market conditions favourable for work-life balance; Social dumping in the EU; Guidelines for the employment policies of the Member States; How best to harness the job creation potential of small and medium-sized enterprises; The application of the Employment Equality Directive; The activities, impact and added value of the European Globalisation Adjustment Fund between 2007 and 2014; Conclusion of a Protocol to the Agreement between the European Community and its Member States, of the one part, and the Swiss Confederation, of the other, on the free movement of persons, regarding the participation of the Republic of Croatia as a Contracting Party, following its accession to the European Union; Tripartite Social Summit for Growth and Employment and repealing Decision 2003/174/EC. The session also included the Oral question on Minimum income schemes in the EU.

Posting of workers in the framework of the provision of services

Hearing - Interparliamentary Committee Meeting

During this hearing, Marianne Thyssen, Commissioner for Employment, Social Affairs, Skills and Labour Mobility, will present the proposal on a "A targeted revision of the rules on the Posting of Workers". There will be interventions by MrĽuboš Blaha, Chair of the European Affairs Committee of the National Council of the Slovak Republic, and by the EMPL Co-rapporteurs, followed by an exchange of views between Members of National Parliaments and of the European Parliament.

European Parliament Pilot Project on Health and Safety of Older Workers

Exchange of views

The European Parliament launched this pilot project to further investigate possible ways of improving the health and safety of older people at work and to ensure better accident prevention for all throughout their working life. The European Commission has delegated the implementation of this project to the European Agency for Safety and Health at Work. The aim of the exchange of views is to present the publications and other outputs produced by the project.

European Network of Public Employment Services (PES)

Exchange of views

During this exchange of views, Fons Leroy, newly appointed Chair of the PES Network, will present the network's activities with particular emphasis on "benchlearning", unemployment and the integration of refugees. The PES network was created following a decision by the Council and the European Parliament to maximise efficiency of public employment services.

Amendment to Directive 2004/37/EC on the protection of workers from the risks related to exposure to carcinogens or mutagens at work

Exchange of views with stakeholders

This exchange of views will feed into the preparation of the draft report on the Amendment to Directive 2004/37/EC on the protection of workers from the risks related to exposure to carcinogens or mutagens at work. There will be representatives from the European Agency for Safety and Health at Work, Imperial College London, the European Trade Union Institute and BusinessEurope.

European Qualifications Framework for lifelong learning

Consideration of oral question and motion for resolution

The EMPL Committee's question for oral answer and draft motion for a resolution concern the proposed revision of the European Qualification Framework for Lifelong Learning (EQF). The European Parliament and the Council adopted a Recommendation on the EQF in 2008 with the aim to improve transparency, comparability and portability of people's

qualifications in Europe. As part of its New Skills Agenda, the Commission proposes to revise the system through a revised Council Recommendation.

Establishing a Skills Guarantee

Consideration of oral question and motion for resolution

The EMPL Committee's question for oral answer and draft motion for a resolution concerns the European Commission's initiative to set up a Skills Guarantee, which will allow low-qualified adults to identify their existing skills and acquire a minimum level of literacy, numeracy and digital skills and/or progress towards an upper secondary qualification or equivalent.

Consideration of draft opinion

In his draft opinion, the rapporteur argues that where fisheries



are concerned, fishermen and their organisations, trade unions, and communities should be made an integral part of the decision-taking

processes. He suggests making information and support more readily available to fishermen's organisations applying for EU funding. Furthermore, he raises the question of a minimum wage for fishermen and points to the need to promote collective negotiation and bargaining so as to safeguard and enhance the rights of workers in the sector.

European Centre for the Development of Vocational Training (Cedefop)

According to Cedefop's European skills and jobs survey (ESJ survey), one in five young Europeans are employed in jobs that require a lower level of qualifications than the one they possess. The recently published ESJ survey INSIGHTS No 7 on "EU workforce: overeducated yet underskilled?" shows that the phenomenon of underskilling is just as important. It looks at how these gaps arise when employees' skills are lower than those required to perform their job. More.
